## 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Eminent Domain Act is amended by adding
Section 25-5-80 as follows:

6 (735 ILCS 30/25-5-80 new) 7 Sec. 25-5-80.
