2 AMENDMENT NO. \_\_\_\_\_. Amend House Bill 452 on page 1,  
3 immediately below line 3, by inserting the following:

4 "Section 3. The Illinois Commission on Volunteerism and  
5 Community Service Act is amended by changing Sections 1, 6.1,  
6 and 7 as follows:

7 (20 ILCS 2330/1) (was 20 ILCS 710/1)

8 Sec. 1. Creation. There is created in the Department of  
9 Human Services ~~Public Health~~ the Illinois Commission on  
10 Volunteerism and Community Service.

13 Sec. 6.1. Functions of Commission. The Commission shall  
14 meet at least quarterly and shall advise and consult with the  
15 Department of Human Services ~~Public Health~~ and the Governor's

1 Office on all matters relating to community service in  
2 Illinois. In addition, the Commission shall have the following  
3 duties:

4 (a) prepare a 3-year State service plan, developed  
5 through an open, public process and updated annually;

6 (b) prepare the financial assistance applications of  
7 the State under the National and Community Service Trust  
8 Fund Act of 1993, as amended by the Serve America Act;

9 (c) assist in the preparation of the application by  
10 the State Board of Education for assistance under that  
11 Act;

12 (d) prepare the State's application under that Act for  
13 the approval of national service positions;

14 (e) assist in the provision of health care and child  
15 care benefits under that Act;

16 (f) develop a State recruitment, placement, and  
17 information dissemination system for participants in  
18 programs that receive assistance under the national  
19 service laws;

20 (g) administer the State's grant program including  
21 selection, oversight, and evaluation of grant recipients;

22 (h) make technical assistance available to enable  
23 applicants to plan and implement service programs and to  
24 apply for assistance under the national service laws;

25 (i) develop projects, training methods, curriculum  
26 materials, and other activities related to service;

1 (j) coordinate its functions with any division of the  
2 federal Corporation for National and Community Service  
3 outlined in the National and Community Service Trust Fund  
4 Act of 1993, as amended by the Serve America Act;

5 (k) publicize Commission services and promote  
6 community involvement in the activities of the Commission;

7 (l) promote increased visibility and support for  
8 volunteers of all ages, especially youth and senior  
9 citizens, and community service in meeting the needs of  
10 Illinois residents; and

11 (m) represent the Department of Human Services ~~Public~~  
12 ~~Health~~ and the Governor's Office on such occasions and in  
13 such manner as the Department may provide.

18 authority, powers, and duties in this Act of the Department of  
19 Public Health ~~Human Services~~ are transferred to the Department  
20 of Human Services ~~Public Health~~."; and

23 "Section 95. Illinois Compiled Statutes reassignment. The

1 Legislative Reference Bureau shall reassign the following Act

3 and file appropriate documents with the Index Division of the  
4 Office of the Secretary of State in accordance with subsection  
5 (c) of Section 5.04 of the Legislative Reference Bureau Act:

6 Illinois Commission on Volunteerism and Community Service  
7 Act, reassigned from 20 ILCS 2330/ to 20 ILCS 1345/.

8 Section 99. Effective date. This Act takes effect upon  
9 becoming law, except that Sections 3 and 95 take effect  
10 January 1, 2022."
