- 4 Section 5. The Circuit Courts Act is amended by changing

- 7 Sec. 1. Judicial circuits created. The The county of Cook
- 8 shall be one judicial circuit and the State of Illinois,
- 9 exclusive of the county of Cook, shall be and is divided into
- 10 judicial circuits as follows:
- 11 First Circuit--The counties of Alexander, Pulaski, Massac,
- 12 Pope, Johnson, Union, Jackson, Williamson and Saline.
- 13 Second Circuit--The counties of Hardin, Gallatin, White,
