A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much thereof
6 as may be necessary, respectively, are appropriated for the
7 ordinary and contingent expenses of the Office of the State
8 Fire Marshal, as follows:

20 Section 5. The sum of \$65,000, or so much thereof as may
 21 be necessary, is appropriated from the Fire Prevention Fund to
 22 the Office of the State Fire Marshal for costs and expenses
 23 related to or in support of the Fire Explorer and Cadet School.

1 Section 10. The sum of \$2,500,000, or so much thereof as
2 may be necessary, is appropriated from the Fire Prevention Fund
3 to the Office of the State Fire Marshal for grants for the
4 Small Equipment Grant Program.

5 Section 15. The sum of \$1,000,000, or so much thereof as
6 may be necessary, is appropriated from the Fire Prevention Fund
7 to the Office of the State Fire Marshal for all costs associated
8 with the Minimum Basic Firefighter Training Program.

9 Section 20. The sum of \$60,000, or so much thereof as may
10 be necessary, is appropriated from the Fire Prevention Fund to
11 the Office of the State Fire Marshal for all costs associated
12 with the Illinois Firefighter Peer Support Program.

13 Section 25. The sum of \$50,000, or so much thereof as may
14 be necessary, is appropriated from the Fire Prevention Fund to
15 the Office of the State Fire Marshal for all costs associated
16 with the Community Risk Reduction Program.

17 Section 30. The sum of \$380,000, or so much thereof as may
18 be necessary, is appropriated from the Fire Prevention Fund to
19 the Office of the State Fire Marshal for all costs associated
20 with the Firefighter Online Training Management System.

1 Section 35. The sum of \$2,000,000, or so much thereof as
 2 may be necessary, is appropriated from the Fire Prevention Fund
 3 to the Office of the State Fire Marshal for all costs associated
 4 with the renovation and rehabilitation of the Fire Museum
 5 Building located on the State Fairground in Springfield.

6 Section 40. The sum of \$75,000, or so much thereof as may
 7 be necessary, is appropriated from the Illinois Fire Fighters'
 8 Memorial Fund to the Office of the State Fire Marshal for
 9 expenses related to the Maintenance and Rehabilitation of the
 10 Fire Museum Building and Museum Artifacts.

11 Section 45. The sum of \$200,000, or so much thereof as may
 12 be necessary, is appropriated from the Illinois Fire Fighters'
 13 Memorial Fund to the Office of the State Fire Marshal for all
 14 costs associated with the Medal of Honor Ceremony, Scholarships
 15 and Firefighter Memorial Maintenance.

16 Section 50. The following named amounts, or so much thereof
 17 as may be necessary, respectively, are appropriated to the
 18 Office of the State Fire Marshal as follows:

19 Payable from the Fire Prevention Fund:

- 20 For Expenses of Senior Officer Training55,000
- 21 For Expenses of the Cornerstone Program350,000
- 22 For Expenses related to Fire Fighter training

8 Section 55. The following named amounts, or so much thereof
 9 as may be necessary, respectively, are appropriated for the
 10 ordinary and contingent expenses of the Office of the State
 11 Fire Marshal, as follows:

19 Section 60. The sum of \$500, or so much thereof as may be
 20 necessary, is appropriated from the Fire Prevention Fund to the
 21 Office of the State Fire Marshal for grants available for the
 22 development of new fire districts.

1 Section 65. The sum of \$240,000, or so much thereof as may
2 be necessary, is appropriated from the Fire Prevention Fund to
3 the Office of the State Fire Marshal for grants available for
4 costs and services related to ILEAS/MABAS administration.

5 Section 70. The sum of \$10,000, or so much thereof as may
6 be necessary, is appropriated from the Fire Prevention Fund to
7 the Office of the State Fire Marshal for a grant to the
8 Hazardous Materials Emergency Response Reimbursement.

9 Section 75. The sum of \$550,000, or so much thereof as may
10 be necessary, is appropriated from the Underground Storage Tank
11 Fund to the Office of the State Fire Marshal for a grant to the
12 City of Chicago for administrative costs incurred as a result
13 of the State's Underground Storage Program.

14 Section 99. Effective Date. This Act takes effect July
15 1, 2021.
