AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

5 Section 5. The amount of \$562,528,200, or so much thereof 6 as may be necessary, is appropriated from the Education 7 Assistance Fund to the Board of Trustees of the University of 8 Illinois to meet its operational expenses for the fiscal year 9 ending June 30, 2022.

Section 15. The sum of \$14,803,100, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for costs and expenses related to or in support of the Prairie HB2732 -2- OMB102 00139 ADR 10139 b Research Institute, in accordance with Public Act 95-0728.

2 Section 20. The sum of \$40,380,600, or so much thereof as 3 may be necessary, is appropriated from the General Revenue Fund 4 to the Board of Trustees of the University of Illinois for 5 operating costs and expenses related to or in support of the 6 University of Illinois Hospital.

Section 25. The sum of \$673,800, or so much thereof as may be necessary, is appropriated from the Education Assistance Fund to the Board of Trustees of the University of Illinois for costs associated with the Hispanic Center for Excellence at the Chicago campus.

Section 30. The sum of \$276,600, or so much thereof as may hereof as hereof hereof hereof as hereof hereof

16 Section 35. The sum of \$1,052,700, or so much thereof as 17 may be necessary, is appropriated from the Education Assistance 18 Fund to the Board of Trustees of the University of Illinois for 19 costs associated with the Public Policy Institute at the 20 Chicago campus. Section 40. The sum of \$294,800, or so much thereof as may
 be necessary, is appropriated from the Education Assistance
 Fund to the Board of Trustees of the University of Illinois for
 a grant to the College of Dentistry.

5 Section 45. The amount of \$500,000, or so much thereof as 6 may be necessary, is appropriated from the General Revenue Fund 7 to the Board of Trustees of the University of Illinois for 8 costs associated with the Illinois Heart Rescue.

9 Section 50. The sum of \$4,427,900, or so much thereof as 10 may be necessary, is appropriated from the Fire Prevention Fund 11 to the Board of Trustees of the University of Illinois for the 12 purpose of maintaining the Illinois Fire Service Institute, 13 paying the Institute's expenses, and providing the facilities 14 and structures incident thereto, including payment to the 15 University for personal services and related costs incurred.

16 Section 55. The sum of \$250,000, or so much thereof as may 17 be necessary, is appropriated from the State College and 18 University Trust Fund to the Board of Trustees of the University 19 of Illinois for scholarship grant awards.

20 Section 60. The sum of \$250,000 or so much thereof as may 21 be necessary, is appropriated from the Pet Population Control HB2732 -4- OMB102 00139 ADR 10139 b Fund to the University of Illinois for costs associated with pet population control at the College of Veterinary Medicine.

3 Section 65. The sum of \$300,000, or so much thereof as may 4 be necessary, is appropriated from the Emergency Public Health 5 Fund to the University of Illinois for costs and expenses 6 related to or in support of Emergency Mosquito Abatement.

Section 70. The sum of \$400,000, or so much thereof as may be necessary, is appropriated from the Used Tire Management Fund to the University of Illinois for costs and expenses related to or in support of mosquito research and abatement.

11 Section 75. The sum of \$500,000, or so much thereof as may 12 be necessary, is appropriated from the Hazardous Waste Research 13 Fund to the University of Illinois for its ordinary and 14 contingent expenses.

15 Section 80. The sum of \$500,000, or so much thereof as may 16 be necessary, is appropriated from the General Professions 17 Dedicated Fund to the Board of Trustees of the University of 18 Illinois for costs associated with the development, support or 19 administration of pharmacy practice education or training 20 programs for the College of Medicine at Rockford.
