Task Force Members. 4 (a) The Resentencing Task Force shall consist of the 5 following members: (1) a member of the House of Representatives appointed 6 7 by the Speaker of the House; 8 (2) a member of the House of Representatives appointed 9 by the Minority Leader of the House; 10 (3) a member of the Senate appointed by the President of the Senate; 11 12 (4) a member of the Senate appointed by the Minority 13 Leader of the Senate; 14 (5) a member appointed by a statewide agency that 15 represents State's Attorneys and is elected to a county of under one million people or his or her designee; 16 (6) a member appointed by a statewide agency that 17 18 represents State's Attorneys; 19 (7) a member appointed by the Office of the State 20 Appellate Defender; 21 (8) a member appointed by an organization that 22 advocates for victims' rights; 23 a member appointed by an organization (9) that 24 advocates for sentencing reform; 25 (10)a member appointed by an organization
