

## 102ND GENERAL ASSEMBLY State of Illinois 2021 and 2022 HB3685

Introduced 2/22/2021, by Rep. Randy E. Frese

## SYNOPSIS AS INTRODUCED:

430 ILCS 66/30

Amends the Firearm Concealed Carry Act. Provides that an application for a concealed carry license shall contain the applicant's valid driver's license number, valid state identification card number, or valid United States Military identification card number.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Firearm Concealed Carry Act is amended by changing Section 30 as follows:

- 7 Sec. 30. Contents of license application.
- 8 (a) The license application shall be in writing, under 9 penalty of perjury, on a standard form adopted by the Department and shall be accompanied by the documentation 10 required in this Section and the applicable fee. Each 11 application form shall include the following statement printed 12 in bold type: "Warning: Entering false information on this 13 14 form is punishable as perjury under Section 32-2 of the Criminal Code of 2012." 15
  - (b) The application shall contain the following:
  - (1) the applicant's name, current address, date and year of birth, place of birth, height, weight, hair color, eye color, maiden name or any other name the applicant has used or identified with, and any address where the applicant resided for more than 30 days within the 10 years preceding the date of the license application;

valid state identification card number, or valid United

States Military identification card number;

- (3) waiver of the applicant's privacy a confidentiality rights and privileges under all federal and state laws, including those limiting access justice, psychological, juvenile court, criminal records or records relating to psychiatric institutionalization of the applicant, and an affirmative request that a person having custody of any of these records provide it or information concerning it to the Department. The waiver only applies to records sought in connection with determining whether the applicant qualifies for a license to carry a concealed firearm under this Act, or whether the applicant remains in compliance with the Firearm Owners Identification Card Act;
- (4) an affirmation that the applicant possesses a currently valid Firearm Owner's Identification Card and card number if possessed or notice the applicant is applying for a Firearm Owner's Identification Card in conjunction with the license application;
- (5) an affirmation that the applicant has not been convicted or found guilty of:
  - (A) a felony;
  - (B) a misdemeanor involving the use or threat of physical force or violence to any person within the 5 years preceding the date of the application; or

(C) 2 or more violations related to driving while
under the influence of alcohol, other drug or drugs,
intoxicating compound or compounds, or any combination
thereof, within the 5 years preceding the date of the
license application; and

- (6) whether the applicant has failed a drug test for a drug for which the applicant did not have a prescription, within the previous year, and if so, the provider of the test, the specific substance involved, and the date of the test:
- (7) written consent for the Department to review and use the applicant's Illinois digital driver's license or Illinois identification card photograph and signature;
- (8) a full set of fingerprints submitted to the Department in electronic format, provided the Department may accept an application submitted without a set of fingerprints in which case the Department shall be granted 30 days in addition to the 90 days provided under subsection (e) of Section 10 of this Act to issue or deny a license;
- (9) a head and shoulder color photograph in a size specified by the Department taken within the 30 days preceding the date of the license application; and
- (10) a photocopy of any certificates or other evidence of compliance with the training requirements under this Act.
