1 AMENDMENT TO HOUSE BILL 5187

2 AMENDMENT NO. _____. Amend House Bill 5187 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The Employee Washroom Act is amended by adding
5 Section 0.05 as follows:

6 (820 ILCS 230/0.05 new)

7 Sec. 0.05. Federal regulations; operation of Act.

8 (a) Except as provided in subsection (b), Sections 1
9 through 5 of this Act are inoperative on and after the
10 effective date of this amendatory Act of the 102nd General
11 Assembly.

12 (b) If at any time the Occupational Safety and Health
13 standard at 29 CFR 1910.141 is repealed or revoked, the
14 Director of Labor shall adopt a rule setting forth a
15 determination that this Act should be reviewed and reinstated
16 in order to protect the health and safety of Illinois'

1 workers. On the date such a rule is adopted, this Act shall
2 again become operative.

3 Section 10. The Work Under Compressed Air Act is amended
4 by adding Section 1.5 as follows:

5 (820 ILCS 245/1.5 new)

6 Sec. 1.5. Federal regulations; operation of Act.

7 (a) Except as provided in subsection (b), Sections 1
8 through 6 of this Act are inoperative on and after the
9 effective date of this amendatory Act of the 102nd General
10 Assembly.

11 (b) If at any time the Safety and Health Regulations for
12 Construction standards at 29 CFR 1926.800 through 29 CFR
13 1926.804 are repealed or revoked, the Director of Labor shall
14 adopt a rule setting forth a determination that this Act
15 should be reviewed and reinstated, in whole or in part, in
16 order to protect the health and safety of Illinois' workers.
17 On the date such a rule is adopted, this Act shall again become
18 operative.

19 Section 15. The Underground Sewer Employee Safety Act is
20 amended by changing Section 1 and by adding Section 0.05 as
21 follows:

2 (a) Except as provided in subsection (b), Sections 1
3 through 6 of this Act are inoperative on and after the
4 effective date of this amendatory Act of the 102nd General
5 Assembly.

6 (b) If at any time the Occupational Safety and Health
7 standards at 29 CFR 1910.120, 29 CFR 1910.146 or the Safety and
8 Health Regulations for Construction standards 29 CFR 1926.1201
9 through 29 CFR 1926.1213 are repealed or revoked, the Director
10 of Labor shall adopt a rule setting forth a determination that
11 this Act should be reviewed and reinstated, in whole or in
12 part, in order to protect the health and safety of Illinois'
13 workers. On the date such a rule is adopted, this Act shall
14 again become operative.

15 (820 ILCS 250/1) (from Ch. 48, par. 1101)

16 Sec. 1. This Act shall apply to all employers engaged in
17 any occupation, business or enterprise in this State,
18 including the State of Illinois and its political
19 subdivisions, ~~except that in the event of a conflict between~~
20 ~~this Act and any other Federal or State law or regulation~~
21 ~~concerning health and safety of employees, such other law or~~
22 ~~regulation shall control.~~

24 Section 20. The Toxic Substances Disclosure to Employees

5 through 17 of this Act are inoperative on and after the
6 effective date of this amendatory Act of the 102nd ~~95th~~
7 General Assembly, ~~and the Department of Labor shall instead~~
8 ~~enforce the Occupational Safety and Health Administration~~
9 ~~Hazard Communication standards at 29 CFR 1910.1200, as~~
10 ~~amended.~~

11 (b) If at any time the Occupational Safety and Health
12 Administration Hazard Communication standard at 29 CFR
13 1910.1200 is repealed or revoked, the Director of Labor shall
14 adopt a rule setting forth a determination that this Act
15 should be reviewed and reinstated in order to protect the
16 health and safety of Illinois' ~~public sector~~ workers. On the
17 date such a rule is adopted, this Act shall again become
18 operative.
