1 HOUSE JOINT RESOLUTION

9 University in 1999; he married Michelle Jean "Shelley" Hillman  
10 on August 18, 2001; and

11 WHEREAS, Todd Hanneken achieved his lifelong goal of  
12 becoming a second generation Illinois State Police Trooper in  
13 December of 2000 as a part of Cadet Class 100; he was assigned  
14 first to State Police District 15 in Downers Grove and then  
15 home to State Police District 10, Pesotum; he received several  
16 professional honors; and
