A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. In addition to other amounts appropriated, the
6 amount of \$6,325,500, or so much thereof as may be necessary,
7 is appropriated from the General Revenue Fund to the Illinois
8 Emergency Management Agency for operational expenses, awards,
9 grants, administrative expenses, including refunds, and
10 permanent improvements.

12 Section 10. The following named amounts, or so much thereof
13 as may be necessary, are appropriated to the Illinois Emergency
14 Management Agency for the objects and purposes hereinafter
15 named:

2 Section 15. The sum of \$114,000, or so much thereof as may
3 be necessary, is appropriated from the Radiation Protection
4 Fund to the Illinois Emergency Management Agency for the
5 ordinary and contingent expenses incurred by the Illinois
6 Emergency Management Agency.

7 Section 20. The sum of \$75,500, or so much thereof as may
8 be necessary, is appropriated from the Nuclear Safety Emergency
9 Preparedness Fund to the Illinois Emergency Management Agency
10 for the ordinary and contingent expenses incurred by the
11 Illinois Emergency Management Agency.

12 Section 25. The sum of \$300,000,000, or so much thereof
13 as may be necessary, is appropriated from the Disaster Response
14 and Recovery Fund to the Illinois Emergency Management Agency
15 for all current and prior year expenses associated with
16 disaster response and recovery.

17 Section 30. The amount of \$500,000,000, or so much of that
18 amount as may be necessary, is appropriated from the State
19 Coronavirus Urgent Remediation Emergency Fund to the Illinois
20 Emergency Management Agency to expend at the direction of the
21 Governor for any costs eligible for payment from federal

1 Coronavirus Relief Fund moneys in accordance with Section 5001
 2 of the federal CARES Act and related federal guidance or from
 3 any other federal fund pursuant to any other provision of
 4 federal law, including current and prior year operational
 5 expenses, awards, and grants of the Illinois Emergency
 6 Management Agency and other State agencies for the support of
 7 programs and services that assist people and entities impacted
 8 by the COVID-19 pandemic and the State's emergency response to
 9 the pandemic. In the discretion of the Governor, and upon his
 10 written direction to the Comptroller, portions of the
 11 appropriated funds may be allotted to other state agencies for
 12 expenditures as authorized in this section.

13 Section 35. The following named amounts, or so much thereof

17 Section 50. The sum of \$275,000, or so much thereof as may
 18 be necessary, is appropriated from the Sheffield February 1982
 19 Agreed Order Fund to the Illinois Emergency Management Agency
 20 for the care, maintenance, monitoring, testing, remediation and
 21 insurance of the low-level radioactive waste disposal site near
 22 Sheffield, Illinois.

11 Section 60. The amount of \$23,010,400, or so much thereof
 12 as may be necessary, is appropriated from the Homeland Security
 13 Emergency Preparedness Trust Fund to the Illinois Emergency
 14 Management Agency for current and prior year expenses related
 15 to the federally funded Emergency Preparedness Grant Program.

16 Section 65. The sum of \$5,000,000, or so much thereof as
 17 may be necessary, is appropriated from the General Revenue Fund
 18 to the Illinois Emergency Management Agency for all costs
 19 associated with homeland security and emergency preparedness
 20 and response, including grants and operational expenses.

21 Section 99. Effective Date. This Act takes effect July 1,
 22 2021.
