A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The sum of \$3,500,000, or so much thereof as may
6 be necessary, is appropriated to the Illinois Student
7 Assistance Commission from the General Revenue Fund to meet its
8 operational expenses for the fiscal year ending June 30, 2022.

9 Section 10. The following named amount, or so much thereof
10 as may be necessary, is appropriated from the General Revenue
11 Fund to the Illinois Student Assistance Commission for the
12 following purpose:

13 To support outreach, research, and
14 training activities3,497,700

15 Section 15. The sum of \$20,000,000, or so much thereof as
16 may be necessary, is appropriated from the General Revenue Fund
17 to the Illinois Student Assistance Commission for deposit into
18 the Illinois Prepaid Tuition Trust Fund.

19 Section 20. The sum of \$479,566,200, or so much thereof

1 as may be necessary, is appropriated to the Illinois Student
2 Assistance Commission from the General Revenue Fund for grant
3 awards to students eligible for the Monetary Award Program, as
4 provided by law, and for agency administrative and operational
5 costs not to exceed 2 percent of the total appropriation in
6 this Section.

7 Section 25. The sum of \$35,000,000, or so much thereof as
8 may be necessary, is appropriated to the Illinois Student
9 Assistance Commission from the General Revenue Fund for
10 payments to eligible public universities for grants to students
11 pursuant to the AIM HIGH pilot program.

12 Section 30. The sum of \$150,000, or so much thereof as may
13 be necessary, is appropriated from the General Revenue Fund to
14 the Illinois Student Assistance Commission for costs associated
15 with providing grants to exonerated persons, as provided by
16 law.

17 Section 35. The sum of \$26,400, or so much thereof as may
18 be necessary, is appropriated from the Education Assistance
19 Fund to the Illinois Student Assistance Commission for costs
20 associated with the Veterans' Home Medical Providers' Loan
21 Repayment Program pursuant to Public Act 99-0813.

1 Section 40. The sum of \$264,000, or so much thereof as may
 2 be necessary, is appropriated from the Education Assistance
 3 Fund to the Illinois Student Assistance Commission for grants
 4 to eligible nurse educators to use for payment of their
 5 educational loan pursuant to Public Act 94-1020.

6 Section 45. The following named sums, or so much thereof
 7 as may be necessary, respectively, are appropriated from the
 8 Education Assistance Fund to the Illinois Student Assistance
 9 Commission for the following purposes:

10 Grants and Scholarships

11	For the payment of scholarships to students	
12	who are children of policemen or firemen	
13	killed in the line of duty, or who are	
14	dependents of correctional officers killed	
15	or permanently disabled in the line of	
16	duty, as provided by law	1,273,300
17	For payment of Minority Teacher Scholarships	<u>1,900,000</u>
18	Total	\$3,173,300

19 Section 50. The sum of \$6,498,000, or so much thereof as
 20 may be necessary, is appropriated from the Education Assistance
 21 Fund to the Illinois Student Assistance Commission to the
 22 Golden Apple Scholars of Illinois program, as provided by law.

1 Section 55. The sum of \$750,000, or so much thereof as may
2 be necessary, is appropriated from the Education Assistance
3 Fund to the Illinois Student Assistance Commission to the
4 Golden Apple Scholars of Illinois program for the Golden Apple
5 Accelerators Program.

6 Section 60. The sum of \$439,900, or so much thereof as may
7 be necessary, is appropriated from the Education Assistance
8 Fund to the Illinois Student Assistance Commission for the Loan
9 Repayment for Teachers Program.

10 Section 65. The sum of \$300,000, or so much thereof as may
11 be necessary, is appropriated from the ISAC Accounts Receivable
12 Fund to the Illinois Student Assistance Commission for costs
13 associated with the collection of delinquent scholarship awards
14 pursuant to the Illinois State Collection Act of 1986.

15 Section 70. The sum of \$110,000, or so much thereof as may
16 be necessary, is appropriated to the Illinois Student
17 Assistance Commission from the University Grant Fund for
18 payment of grants for the Higher Education License Plate
19 Program, as provided by law.

20 Section 75. The following named sum, or so much thereof
21 as may be necessary, is appropriated from the Illinois Student

1 Assistance Commission Contracts and Grants Fund to the Illinois
2 Student Assistance Commission for the following purpose:

3 To support outreach, research, and
4 training activities10,000,000

5 Section 80. The following named sum, or so much thereof
6 as may be necessary, is appropriated from the Optometric
7 Licensing and Disciplinary Board Fund to the Illinois Student
8 Assistance Commission for the following purpose:

9 Grants and Scholarships
10 For payment of scholarships for the
11 Optometric Education Scholarship
12 Program, as provided by law50,000

13 Section 85. The following named sum, or so much thereof
14 as may be necessary, is appropriated from the National Guard
15 and Naval Militia Grant Fund to the Illinois Student Assistance
16 Commission for the following purpose:

17 Grants and Scholarships
18 For payment of Illinois National Guard and
19 Naval Militia Scholarships
20 at State-controlled universities
21 and public community colleges in
22 Illinois to students eligible to
23 receive such awards, as provided by law20,000

1 Section 90. The sum of \$100,000, or so much thereof as may
 2 be necessary, is appropriated from the Golden Apple Scholars
 3 of Illinois Fund to the Illinois Student Assistance Commission
 4 for the Golden Apple Scholars of Illinois Program, as provided
 5 by law.

6 Section 95. The following named sums, or so much thereof
 7 as may be necessary, respectively, are appropriated to the
 8 Illinois Student Assistance Commission from the Student Loan
 9 Operating Fund for its ordinary and contingent expenses:

3 Section 100. The sum of \$2,500,000, or so much thereof as
 4 may be necessary, is appropriated to the Illinois Student
 5 Assistance Commission from the Student Loan Operating Fund for
 6 costs associated with Federal Loan System Development and
 7 Maintenance.

8 Section 105. The sum of \$1,000,000 or so much thereof as
 9 may be necessary, is appropriated to the Illinois Student
 10 Assistance Commission from the Student Loan Operating Fund for
 11 costs associated with the Illinois Designated Account Purchase
 12 Program.

13 Section 110. The sum of \$10,000,000, or so much thereof
 14 as may be necessary, is appropriated to the Illinois Student
 15 Assistance Commission from the Student Loan Operating Fund for
 16 distribution as necessary for the following: for payment of
 17 collection agency fees associated with collection activities
 18 for Federal Family Education Loans, for Default Aversion Fee
 19 reversals, and for distributions as necessary and provided for
 20 under the Federal Higher Education Act.

21 Section 115. The following named sum, or so much thereof

1 as may be necessary, is appropriated from the Federal
2 Congressional Teacher Scholarship Program Fund to the Illinois
3 Student Assistance Commission for the following purpose:

4 For transferring repayment funds collected
5 under the Paul Douglas Teacher Scholarship
6 Program to the U.S. Treasury100,000

7 Section 120. The sum of \$160,000,000, or so much thereof
8 as may be necessary, is appropriated from the Federal Student
9 Loan Fund to the Illinois Student Assistance Commission for
10 distribution when necessary as a result of the following: for
11 guarantees of loans that are uncollectible, for collection
12 payments to the Student Loan Operating Fund as required under
13 agreements with the United States Secretary of Education, for
14 payment to the Student Loan Operating Fund for Default Aversion
15 Fees, for transfers to the U.S. Treasury, or for other
16 distributions as necessary and provided for under the Federal
17 Higher Education Act.

18 Section 125. The sum of \$13,000,000, or so much thereof
19 as may be necessary, is appropriated from the Federal Student
20 Incentive Trust Fund to the Illinois Student Assistance
21 Commission for allowable uses of federal grant funds related
22 to college access, outreach, and training, including but not
23 limited to funds received under the federal Gaining Early

1 Awareness and Readiness for Undergraduate Program.

2 Section 130. The sum of \$300,000, or so much thereof as
3 may be necessary, is appropriated from the Federal Student
4 Incentive Trust Fund to the Illinois Student Assistance
5 Commission for the John R. Justice Student Loan Repayment
6 Program.

7 Section 999. Effective Date. This Act takes effect July
8 1, 2021.
