A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof
6 as may be necessary, respectively, for the objects and purposes
7 hereinafter named, are appropriated to meet the ordinary and
8 contingent expenses of the Law Enforcement Training Standards
9 Board:

19 Section 10. The following named amount, or so much thereof
20 as may be necessary, respectively, for the objects and purposes
21 hereinafter named, is appropriated to the Law Enforcement
22 Training Standards Board as follows:

23 GRANTS-IN-AID

24 Payable from the Traffic and Criminal

1 Conviction Surcharge Fund:
 2 For payment of and/or reimbursement
 3 of basic training and basic training services
 4 in accordance with statutory provisions9,800,000
 5 For payment of and/or reimbursement
 6 of in-service training and in-service training services
 7 in accordance with statutory provisions16,400,000

8 Section 15. The amount of \$8,000,000, or so much thereof
 9 as may be necessary, is appropriated from the General Revenue
 10 Fund to the Law Enforcement Training Standards Board for
 11 deposit into the Traffic and Criminal Conviction Surcharge
 12 Fund. No portion of this appropriation shall be deposited into
 13 the Traffic and Criminal Conviction Surcharge Fund unless and
 14 until it is approved in writing by the Governor

15 Section 20. The sum of \$1,000,000, or so much thereof as
 16 may be necessary, is appropriated from the Law Enforcement
 17 Officers Training Board Federal Projects Fund to the Law
 18 Enforcement Training Standards Board for expenses relating to
 19 various federal projects.

20 Section 99. Effective Date. This Act takes effect July 1,
 21 2021.
