## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The State Commemorative Dates Act is amended by 5 adding Section 63 as follows:

6 (5 ILCS 490/63)

7 Sec. 63. Juneteenth National Freedom Day. The nineteenth day of June of each year is a holiday to be observed throughout 8 9 the State and to be known third Saturday in June of each year Juneteenth National 10 is designated as Freedom Dav to commemorate the abolition of slavery throughout the United 11 States and its territories in 1865. Juneteenth National 12 Freedom Day may be observed with suitable observances and 13 14 exercises by civic groups and the public, and citizens of the State are urged to reflect on the suffering endured by early 15 African-Americans and to celebrate the unique freedom and 16 17 equality enjoyed by all State citizens today. When June nineteenth shall fall on a Sunday, the following Monday shall 18 19 be held and considered the holiday.

21 Section 10. The Election Code is amended by changing 22 Section 1-6 as follows: 1

(10 ILCS 5/1-6)

Sec. 1-6. Computing dates of various acts; Saturday,
Sunday, and holidays.

4 (a) If the first or last day fixed by law to do any act 5 required or allowed by this Code falls on a State holiday or a 6 Saturday or a Sunday, the period shall extend through the 7 first business day next following the day otherwise fixed as 8 the first or last day, irrespective of whether any election 9 authority or local election official conducts business on the 10 State holiday, Saturday, or Sunday.

11 (b) For the purposes of this Section, "State holiday" 12 means New Year's Day, Dr. Martin Luther King, Jr.'s Birthday, 13 Lincoln's Birthday, President's Day, Casimir Pulaski's 14 Birthday, Good Friday, Memorial Day, Juneteenth National 15 Freedom Day, Independence Day, Labor Day, Columbus Day, 16 Veterans' Day, Thanksgiving Day, Christmas Day, and any other day from time to time declared by the President of the United 17 18 States or the Governor of Illinois to be a day during which the agencies of the State of Illinois that are ordinarily open to 19 do business with the public shall be closed for business. 20

(c) Notwithstanding any other provision of this Code, nominating papers, petitions of objection to nominating papers, certificates of withdrawal of candidacy, and reports of political committees actually received by election authorities and local election officials on a State holiday, a

The Illinois Procurement Code is amended by 5 changing Section 15-45 as follows: (30 ILCS 500/15-45) 6 7 Sec. 15-45. Computation of days. The time within which any 8 act provided in this Code is to be done shall be computed by 9 excluding the first day and including the last, unless the 10 last day is Saturday or Sunday or is a holiday, and then it 11 shall also be excluded. If the day succeeding a Saturday, Sunday, or holiday is also a holiday, a Saturday, or a Sunday, 12 13 then that succeeding day shall also be excluded. For the purposes of this Code, "holiday" means: New Year's Day; Dr. 14 15 Martin Luther King, Jr.'s Birthday; Lincoln's Birthday; President's Day; Memorial Day; Juneteenth National Freedom 16 17 Day; Independence Day; Labor Day; Columbus Day; Veterans' Day; 18 Thanksqiving Day; Christmas Day; and any other day from time to time declared by the President of the United States or the 19 20 Governor of Illinois to be a day during which the agencies of 21 the State of Illinois that are ordinarily open to do business with the public shall be closed for business. 22

Day. School boards may grant special holidays whenever in their judgment such action is advisable. No deduction shall be made from the time or compensation of a school employee on account of any legal or special holiday.

5 (b) A school board or other entity eligible to apply for waivers and modifications under Section 2-3.25g of this Code 6 is authorized to hold school or schedule teachers' institutes, 7 8 parent-teacher conferences, or staff development on the third 9 Monday in January (the Birthday of Dr. Martin Luther King, 10 Jr.); February 12 (the Birthday of President Abraham Lincoln); 11 the first Monday in March (known as Casimir Pulaski's 12 birthday); the second Monday in October (Columbus Day); and November 11 (Veterans' Day), provided that: 13

(1) the person or persons honored by the holiday are recognized through instructional activities conducted on that day or, if the day is not used for student attendance, on the first school day preceding or following that day; and

(2) the entity that chooses to exercise this authority first holds a public hearing about the proposal. The entity shall provide notice preceding the public hearing to both educators and parents. The notice shall set forth the time, date, and place of the hearing, describe the proposal, and indicate that the entity will take testimony from educators and parents about the proposal.

patriotic, civic, cultural or historical persons, activities, 1 2 or events, are regular school days. Commemorative holidays 3 are: January 28 (to be known as Christa McAuliffe Day and observed as a commemoration of space exploration), February 15 4 5 (the birthday of Susan B. Anthony), March 29 (Viet Nam War 6 Veterans' Day), September 11 (September 11th Dav of 7 Remembrance), the school day immediately preceding Veterans' Day (Korean War Veterans' Day), October 1 (Recycling Day), 8 9 October 7 (Iraq and Afghanistan Veterans Remembrance Day), 10 December 7 (Pearl Harbor Veterans' Day), and any day so 11 appointed by the President or Governor. School boards may 12 establish commemorative holidays whenever in their judgment 13 action is advisable. School boards shall such include 14 instruction relative to commemorated persons, activities, or 15 events on the commemorative holiday or at any other time 16 during the school year and at any point in the curriculum when 17 such instruction may be deemed appropriate. The State Board of Education shall prepare and make available to school boards 18 instructional materials relative to commemorated persons, 19 20 activities, or events which may be used by school boards in 21 conjunction with any instruction provided pursuant to this 22 paragraph.

 If March 4 falls on a Saturday or Sunday, Mayors' Day shall be

5 (e) Notwithstanding any other provision of State law to the contrary, November 3, 2020 shall be a State holiday known 6 7 as 2020 General Election Day and shall be observed throughout 8 the State pursuant to this amendatory Act of the 101st General 9 Assembly. All government offices, with the exception of 10 election authorities, shall be closed unless authorized to be 11 used as a location for election day services or as a polling 12 place.

Section 25. The Promissory Note and Bank Holiday Act is amended by changing Section 17 as follows:

(a) The following days shall be legal holidays in the
State of Illinois upon which day a bank may, but is not
required to, remain closed:

21 the first day of January (New Year's Day);

24 the twelfth day in February (Abraham Lincoln's birthday);

the third Monday in February (Presidents Day); 1 2 the first Monday in March (observance of Casimir Pulaski's 3 birthday); the Friday preceding Easter Sunday (Good Friday); 4 5 the last Monday of May (Memorial Day); the nineteenth day of June (Juneteenth National Freedom 6 7 Day); 8 the fourth day of July (Independence Day); 9 the first Monday in September (Labor Day); 10 the second Monday in October (Columbus Day); 11 the eleventh day of November (Veterans' Day); 12 the fourth Thursday in November (Thanksgiving Day); 13 the twenty-fifth day in December (Christmas Day); 14 the days upon which the general elections for members of 15 the House of Representatives are held, and any day proclaimed 16 by the Governor of this State as a legal holiday. From 12 17 o'clock noon to 12 o'clock midnight of each Saturday shall be considered a half holiday. In addition to such holidays and 18

half-holidays, a bank may select one day of the week to remainclosed, as provided in subsection (b) of this Section.

(b) Any bank doing business within this State may select any one day of the week to remain closed on a regular basis upon adoption of a resolution by the board of directors of such bank designating the day selected and upon filing and publishing a copy of such resolution as hereinafter required. of this Section only when a copy thereof, certified by an 1 2 officer having charge of the records of such bank, is filed with the Recorder of the county in which such bank is located 3 and published once each week for 3 successive weeks in a 4 general circulation in such county. 5 newspaper of Such publication shall be accomplished by, and at the expense of, 6 7 the bank, and the bank shall submit to the Commissioner of 8 Banks and Real Estate such evidence of the publication as the 9 Commissioner shall deem appropriate. Any such selection shall 10 remain in full force and effect until a copy of the later 11 resolution of the board of directors of such bank, certified 12 in like manner, terminating or altering any such prior selection shall be filed and published in the same manner as 13 14 such prior resolution.

15 (c) If an occasion arises when a state bank wishes to 16 remain closed on a particular day, other than a day on which 17 the bank has selected to remain closed on a regular basis as provided in this Section, such state bank may remain closed on 18 such an occasion after first sending to the Commissioner a 19 20 copy of a resolution adopted by the board of directors authorizing the bank to remain closed on such occasion and 21 22 notice of the intent to remain closed on such occasion shall be 23 conspicuously posted in the lobby of the main banking office and any branches of such bank for at least 3 weeks in advance 24 25 of such occasion. Any day which any bank doing business within the State shall select to remain closed pursuant to this 26

 considered as a Sunday.

(d) All legal holidays, the half holidays and any day 3 selected by a bank doing business within the State to remain 4 5 closed, shall, for all purposes whatsoever, as regards the presenting for payment or acceptance, the maturity and 6 protesting and giving of notice of the dishonor of bills of 7 8 bank checks and promissory notes exchange, and other 9 negotiable or commercial paper or instrument, be treated and 10 considered as a Sunday. When any such holidays fall on Sunday, 11 the Monday next following shall be held and considered such 12 holiday. All notes, bills, drafts, checks or other evidence of 13 indebtedness, falling due or maturing on either of such days, 14 shall be deemed as due or maturing upon the day following, and 15 when 2 or more of these days come together, or immediately 16 succeeding each other, then such instruments, paper or 17 indebtedness shall be deemed as due or having matured on the day following the last of such days. 18

(e) Any act authorized, required or permitted to be performed at or by or with respect to any bank doing business within the State on a day which it has selected to remain closed under this Section may be so performed on the next succeeding business day and no liability or loss of rights of any kind shall result from such delay.

certification, or acceptance of a check or other negotiable 1 instrument, or any other transaction by a bank in this State, 2 3 because done or performed on any Saturday, Sunday, holiday, or any day selected by a bank to remain closed, or during any time 4 5 other than regular banking hours; but no bank in this State, 6 which by law or custom is entitled to remain open or to close 7 for the whole or any part of any day selected by it to remain 8 open or to close, is compelled to close, or to remain open for 9 the transaction of business or to perform any of the acts or 10 transactions aforesaid except at its own option.

Section 99. Effective date. This Act takes effect upon becoming law.
