

102ND GENERAL ASSEMBLY State of Illinois 2021 and 2022 SB2261

Introduced 2/26/2021, by Sen. Chapin Rose

SYNOPSIS AS INTRODUCED:

35 ILCS 5/232 new

Amends the Illinois Income Tax Act. Creates an income tax credit in an amount equal to 10% of the manufacturing capital expenditures incurred by the taxpayer during the taxable year, or 15% of the manufacturing capital expenditures if the taxpayer is located in a rural or economically challenged area. Provides that the total amount of credits awarded under those provisions may not exceed \$10,000,000 for any particular taxpayer in any taxable year, except that, if the capital investment is made in a rural or economically challenged area, then the maximum amount of the credit shall be \$20,000,000. Effective immediately.

FISCAL NOTE ACT MAY APPLY

1 AN ACT concerning revenue.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Income Tax Act is amended by adding Section 232 as follows:
- 6 (35 ILCS 5/232 new)
- 7 Sec. 232. Manufacturing capital expenditure credit. For taxable years that begin on or after January 1, 2022 and begin 8 9 prior to January 1, 2033, each taxpayer that is engaged in the business of manufacturing (North American Industry 10 Classification System code 31-33) is entitled to a credit 11 against the taxes imposed by subsections (a) and (b) of 12 13 Section 201 in an amount equal to 10% of the capital 14 expenditures incurred by the taxpayer during the taxable year that are related to manufacturing. The total amount of credits 15 16 awarded under this Section may not exceed \$10,000,000 for any 17 particular taxpayer in any taxable year, except that, if the capital investment is made in a rural or economically 18 19 challenged area, as determined by the Department of Commerce and Economic Opportunity, then the amount of the credit shall 20 21 be 15% of the capital expenditure, and the maximum amount of 22 the credit shall be \$20,000,000. A taxpayer may not claim a credit under this Section if the taxpayer claims a credit 2.3

- 1 against the taxes imposed by subsections (a) and (b) of
- 2 <u>Section 201 for the same capital expenditure under any other</u>
- 3 provision of law.
- In no event shall a credit under this Section reduce the
- 5 taxpayer's liability under this Act to less than zero. The
- 6 <u>credit may not be carried forward or back.</u>
- 7 Section 99. Effective date. This Act takes effect upon
- 8 becoming law.
