### SYNOPSIS AS INTRODUCED:

5 ILCS 420/4A-102.5 new

5 ILCS 420/4A-103

from Ch. 127, par. 604A-103

Amends the Illinois Governmental Ethics Act. Provides for additional statement of economic interests disclosures for members of the General Assembly and candidates for nomination or election to the General Assembly, including disclosure of interests held by the spouses of such persons. Modifies the statement of economic interests form to make conforming changes.

A BILL FOR

1 AN ACT concerning government.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Illinois Governmental Ethics Act is amended  
5 by changing Section 4A-103 and by adding Section 4A-102.5 as  
6 follows:

7 (5 ILCS 420/4A-102.5 new)

8 Sec. 4A-102.5. General Assembly statement of economic  
9 interests.

10 (a) In addition to the requirements of Section 4A-102,  
11 members of the General Assembly and candidates for nomination  
12 or election to the General Assembly shall disclose economic  
13 interests as provided in this Section. The interest (if  
14 constructively controlled by the person making the statement)  
15 of a spouse or any other party, shall be considered to be the  
16 same as the interest of the person making the statement. The  
17 person making the statement shall also disclose the interests  
18 of his or her spouse, regardless of whether such interest is  
19 constructively controlled by that person, if such interest  
20 would otherwise be required to be disclosed under this  
21 Section.

22 (b) The statement of economic interests required under  
23 this Section shall include disclosure of the following:

1           (1) all interests in any professional organization or  
2           individual professional practice in which the person  
3           making the statement was an officer, director, associate,  
4           partner, or proprietor, or served in any advisory  
5           capacity;

6           (2) all professional services (other than services  
7           rendered to the unit or units of government in relation to  
8           which the person is required to file) and the nature of the  
9           entity to which they were rendered;

10           (3) the identity (including the address or legal  
11           description of real estate) of any capital asset;

12           (4) the name and instrument of ownership in any entity  
13           doing business in the State of Illinois;

14           (5) the name of any entity employed by and any  
15           position held therein;

16           (6) the name and instrument of ownership in any entity  
17           doing business with a unit of State or local government in  
18           relation to which the person is required to file;

19           (7) the name of any entity and the nature of the  
20           governmental action requested by any entity which has  
21           applied to a unit of local government in relation to which  
22           the person must file for any license, franchise, or permit  
23           for annexation, or for zoning or rezoning of real estate  
24           during the preceding calendar year; and

25           (8) all clients doing business with the State of  
26           Illinois or a unit of local government if the person

1       making the statement was an officer, director, associate,  
 2       partner, or proprietor, or served in any advisory capacity  
 3       during the preceding calendar year.

 5       Sec. 4A-103. The statement of economic interests required  
 6       by this Article to be filed with the Secretary of State shall  
 7       be filled in by typewriting or hand printing, shall be  
 8       verified, dated, and signed by the person making the statement  
 9       and shall contain substantially the following:
