SYNOPSIS AS INTRODUCED:

20 ILCS 605/605-1055 new

Amends the Department of Commerce and Economic Opportunity Law of the Civil Administrative Code of Illinois. Provides that the Department of Commerce and Economic Opportunity may require a business organization to agree to certain terms that ensure the business is a good corporate citizen as a condition for receiving development assistance. Provides that a business that cannot truthfully agree to any required terms shall be ineligible for the development assistance. Specifies terms that may be required. Provides that compliance with good corporate citizen eligibility is required throughout a development assistance agreement. Provides that the Department may seek revocation of any credits or exemptions that were earned or used during a time when the business or its corporate parent or affiliate was not in compliance with any applicable requirements. Provides for the adoption of rules. Defines terms.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Department of Commerce and Economic
Opportunity Law of the Civil Administrative Code of Illinois
is amended by adding Section 605-1055 as follows:

7 (20 ILCS 605/605-1055 new) Sec. 605-1055. Good corporate citizen requirement for tax 8 9 incentive recipients. (a) As used in this Section: 10 11 "Business" means an applicant for or recipient of 12 development assistance. "Corporate parent or affiliate" means: (i) a related 13 14 member with respect to a business; or (ii) an entity that exercises control over the business and whose interests are 15 16 served by the business. 17 "Development assistance" means tax credits and tax exemptions given as an incentive to a business organization 18 19 pursuant to an agreement with the Department or an initial 20 certification or designation issued by the Department. This 21 term does not include any Department-administered tax credit

22 program that provides a tax credit to an investor in a

1	"Development assistance agreement" means: (i) any				
2	agreement or memorandum of understanding executed by the State				
3	granting body and the business organization participating in				
4	the development assistance program setting forth the terms and				
5	conditions of development assistance to be provided to the				
6	recipient consistent with the final application for				
7	development assistance, including, but not limited to, the				
8	date of assistance, submitted to and approved by the				
9	Department; and (ii) any application for certification or				
10	designation setting forth the terms and conditions of				
11	development assistance to be provided to the recipient that is				
12	approved by the Department.				
13	"Good corporate citizen" means a business that has				
14	demonstrated a capacity for legal compliance and that will be				
15	responsible to its community and its workforce.

19	"Related member" has the same meaning as set forth in

2 <u>not be limited to, covenants, representations, and warranties</u>

4 (1) the business, its corporate officers, or corporate
5 parent or affiliate, are not or have not been the subject
6 of any criminal investigations or charges;

(2) there has been no investigation conducted or 7 8 charges, complaints, or actions brought by the State of 9 Illinois or any governmental body within the State of 10 Illinois, including the federal government, with respect 11 to the business or its officers or directors or a 12 corporate parent or affiliate that relates to alleged fraud or activity that poses a substantial threat or 13 14 persistent nuisance to public health, safety, or welfare;

15 (3) the business and any corporate parent or affiliate 16 are not delinquent on the payment of any taxes to the State 17 of Illinois or on the Illinois Stop Payment List or a 18 debarred or suspended parties list maintained by the State 19 of Illinois or the United States; and

Workplace Act, and the federal National Labor Relations 1 2 Act. (c) Compliance with good corporate citizen eligibility is 3 4 required throughout a development assistance agreement. The 5 Department may seek revocation of any credits or exemptions 6 that were earned or used during a time when the business or its corporate parent or affiliate was not in compliance with any 7 8 applicable requirements. 9 (d) The Department shall adopt rules setting forth any 10 other programmatic terms and conditions and the consequences 11 for noncompliance during the term of a development assistance 12 agreement. The Department may adopt rules providing for exceptions to the good corporate citizen requirements if an 13 14 application would, in the determination of the Department, 15 cause an imminent and demonstrable hardship to the people of 16 Illinois or to the business's workforce. If an exception is 17 granted, the business must agree to a contractual modification 18 identifying the exception and the basis for granting it.
