### SYNOPSIS AS INTRODUCED:

Appropriates \$17,129,100 from the General Revenue Fund to the State Board of Elections for operational expenses, grants, reimbursements, and the Census 2020 Redistricting Program for the fiscal year ending June 30, 2020. Appropriates various amounts from the Personal Property Tax Replacement Fund to the State Board of Elections for its ordinary and contingent expenses. Reappropriates amounts from the Help Illinois Vote Fund to the State Board of Elections for implementation of the Help America Vote Act of 2002. Effective July 1, 2019.

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 Section 5. In addition to other sums appropriated, the sum  
5 of \$17,129,100, or so much thereof as may be necessary, is  
6 appropriated from the General Revenue Fund to the State Board  
7 of Elections for operational expenses, grants, reimbursements,  
8 and the Census 2020 Redistricting Program for the fiscal year  
9 ending June 30, 2020.

10 Section 10. The following amounts, or so much of those  
11 amounts as may be necessary, respectively, are appropriated  
12 from the Personal Property Tax Replacement Fund to the State  
13 Board of Elections for its ordinary and contingent expenses as  
14 follows:

15 For reimbursement to counties for increased compensation  
16 judges and other election officials, as provided in  
17 Public Acts 81-850, 81-1149, and 90-672 - Election  
18 Day Judges only .....\$2,300,000  
19 For payment of lump sum awards to county clerks, county  
20 recorders, and chief election clerks as compensation for  
21 additional duties required of such officials by consolidation  
22 of elections law, as provided in Public Acts 82-691

1	and 90-713 .....	<u>\$793,000</u>

3 Section 15. The following amounts, or so much thereof as  
 4 may be necessary, are reappropriated from the Help Illinois  
 5 Vote Fund to the State Board of Elections for implementation  
 6 of the Help America Vote Act of 2002:

7	For the implementation of the Statewide Voter Registration	
8	System, as required by Section 1A-25 of the Election Code,	
9	including maintenance of the IDEA/VISTA program ..	\$1,188,000
10	For administrative costs and discretionary grants to local	
11	election authorities under Section 101 of the Help	
12	America Vote Act of 2002 .....	<u>\$267,200</u>
13	For administrative costs and discretionary grants to local	
14	election authorities under the 2018 HAVA Election Security	
15	Grant .....	<u>\$12,367,900</u>
16	Total	\$13,823,100

17 Section 99. Effective date. This Act takes effect July 1,
