SYNOPSIS AS INTRODUCED:

Makes various appropriations to the Office of the State Comptroller for the fiscal year ending June 30, 2022. Effective July 1, 2021.

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 Section 5. The sum of \$21,636,700, or so much thereof as
5 may be necessary, is appropriated to meet the ordinary and
6 contingent expenses of the Office of the State Comptroller.

7 Section 10. The sum of \$1,500,000, or so much thereof as
8 may be necessary, is appropriated to the State Comptroller from
9 the Comptroller's Administrative Fund for the discharge of
10 duties of the office.

11 Section 15. The sum of \$50,300, or so much thereof as may
12 be necessary, is appropriated to the State Comptroller from the
13 State Lottery Fund for expenses in connection with the State
14 Lottery.

15 Section 20. The following named sums, or so much thereof
16 as may be necessary, respectively, for the objects and purposes
17 hereinafter named, are appropriated to the Office of the State
18 Comptroller for the fiscal year ending June 30, 2022:
