SYNOPSIS AS INTRODUCED:

40 ILCS 5/11-181

from Ch. 108 1/2, par. 11-181

Amends the Chicago Laborers Article of the Illinois Pension Code. In a provision concerning the board of trustees, provides that the City Treasurer, with the prior approval of the board, may also appoint a designee from among employees of the city who is versed in the affairs of the City Treasurer's office to act in the absence of the City Treasurer on all matters pertaining to administering the Article. Makes grammatical changes. Effective immediately.

A BILL FOR

1 AN ACT concerning public employee benefits.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Illinois Pension Code is amended by
5 changing Section 11-181 as follows:

6 (40 ILCS 5/11-181) (from Ch. 108 1/2, par. 11-181)

7 Sec. 11-181. Board created. A board of 8 members shall
8 constitute the board of trustees authorized to carry out the
9 provisions of this Article. The board shall be known as the
10 Retirement Board of the Laborers' and Retirement Board
11 Employees' Annuity and Benefit Fund of the city. The board
12 shall consist of 5 persons appointed and 2 employees and one
13 annuitant elected in the manner hereinafter prescribed.

14 The appointed members of the board shall be appointed as
15 follows:

16 One member shall be appointed by the comptroller of the
17 city, who may be the comptroller ~~himself~~ or anyone chosen by
18 the comptroller from among employees of the city who is ~~are~~
19 versed in the affairs of the comptroller's office. One ~~one~~
20 member shall be appointed by the City Treasurer of the city,
21 who may be the City Treasurer ~~himself~~ or a person chosen from
22 among employees of the city who is ~~are~~ versed in the affairs of
23 the City Treasurer's office; the City Treasurer, with the

1 prior approval of the board, may also appoint a designee from
2 among employees of the city who is versed in the affairs of the
3 City Treasurer's office to act in the absence of the City
4 Treasurer on all matters pertaining to administering the
5 provisions of this Article. One ~~one~~ member shall be an
6 employee of the city appointed by the president of the local
7 labor organization representing a majority of the employees
8 participating in the Fund. Two ~~and 2~~ members shall be
9 appointed by the civil service commission or the Department of
10 Personnel of the city from among employees of the city who are
11 versed in the affairs of the civil service commission's office
12 or the Department of Personnel.

13 The member appointed by the comptroller shall hold office
14 for a term ending on December 1st of the first year following
15 the year of appointment. The member appointed by the City
16 Treasurer shall hold office for a term ending on December 1st
17 of the second year following the year of appointment. The
18 member appointed by the civil service commission shall hold
19 office for a term ending on the first day in the month of
20 December of the third year following the year of appointment.
21 The additional member appointed by the civil service
22 commission under this amendatory Act of 1998 shall hold office
23 for an initial term ending on December 1, 2000, and the member
24 appointed by the labor organization president shall hold
25 office for an initial term ending on December 1, 2001.
26 Thereafter each appointive member shall be appointed by the

1 officer or body that appointed his predecessor, for a term of 3
2 years.

3 The 2 employee members of the board shall be elected as
4 follows:

5 Within 30 days from and after the appointive members have
6 been appointed and have qualified, the appointive members
7 shall arrange for and hold an election.

8 One employee shall be elected for a term ending on
9 December 1st of the first year next following the effective
10 date; one for a term ending on December 1st of the following
11 year.

12 An employee member who takes advantage of the early
13 retirement incentives provided under this amendatory Act of
14 the 93rd General Assembly may continue as a member until the
15 end of his or her term.

16 The initial annuitant member shall be appointed by the
17 other members of the board for an initial term ending on
18 December 1, 1999. The annuitant member elected in 1999 shall
19 be deemed to have been elected for a 3-year term ending on
20 December 1, 2002. Thereafter, the annuitant member shall be
21 elected for a 3-year term ending on December 1st of the third
22 year following the election.
