SYNOPSIS AS INTRODUCED:

50 ILCS 205/30 new 50 ILCS 205/35 new

Amends the Local Records Act. Provides that a unit of local government shall compile a list of: (i) the pay and benefits of every employee, consultant, contractor, and other personnel of the unit of local government whose accumulated payments or compensation are at least \$1,000 during each fiscal year; and (ii) each entity, product, or service supplied by each entity, and amount paid to each entity for any expenditure of government funds greater than \$3,000 from the unit of local government during a fiscal year. Provides that the lists shall continue to be updated throughout the entire fiscal year by adding additional names of persons being paid at least \$1,000 and for expenditures of government funds greater than \$3,000. Provides that the unit of local government shall publish on its website, if it has one, the compiled lists and shall update the lists at least annually. Provides that, if the unit of local government does not have a website, the unit of local government shall publish the lists, on an annual basis, in a newspaper of general circulation in the county in which the unit of local government is located. Limits home rule powers.

4 Section 5. The Local Records Act is amended by adding 5 Sections 30 and 35 as follows:

6 (50 ILCS 205/30 new)

7 <u>Sec. 30. Compensation greater than \$1,000.</u>

(a) A unit of local government shall compile a list of the 8 9 pay and benefits of every employee, consultant, contractor, and other personnel of the unit of local government whose 10 accumulated payments or compensation are at least \$1,000 11 12 during each fiscal year. Exempt material listed under Section 7 of the Freedom of Information Act shall not be included in 13 14 the list. The list shall continue to be updated throughout the entire fiscal year by adding additional names of persons whose 15 16 accumulated payments or compensation are at least \$1,000.

17 (b) A unit of local government shall publish on its 18 website, if it has one, the public record compiled under 19 subsection (a) and shall update the list at least annually. If 20 the unit of local government does not have a website, the unit 21 of local government shall publish the list, on an annual 22 basis, in a newspaper of general circulation in the county in 23 which the unit of local government is located.
