A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The sum of \$1,735,500, or so much thereof as
6 may be necessary, is appropriated from the General Revenue Fund
7 to the Illinois Arts Council for operational expenses for the
8 fiscal year ending June 30, 2023.

9 Section 5. The following named sums, or so much thereof
10 as may be necessary, respectively, for the objects and purposes
11 hereinafter named, are appropriated to the Illinois Arts
12 Council to enhance the cultural environment in Illinois:

13 Payable from General Revenue Fund:

14	For Grants and Financial Assistance for	
15	Creative Sector (Arts Organizations and

17	For Grants and Financial Assistance for	
18	Underserved Constituencies	1,120,000

1 Payable from the Illinois Arts Council
 2 Federal Grant Fund:
 3 For Grants and Programs to Enhance
 4 the Cultural Environment1,000,000

5 Section 10. The sum of \$1,000,000, or so much thereof as
 6 may be necessary, is appropriated from the General Revenue Fund
 7 to the Illinois Arts Council for the purpose of funding
 8 administrative and grant expenses associated with programs
 9 supporting the visual arts, performing arts, languages, and
 10 related activities.

11 Section 15. The amount of \$1,507,100, or so much thereof
 12 as may be necessary, is appropriated from the General Revenue
 13 Fund to the Illinois Arts Council for grants to certain public
 14 radio and television stations and related administrative
 15 expenses, pursuant to the Public Radio and Television Grant
 16 Act.

17 Section 20. In addition to other amounts appropriated for
 18 this purpose, the following named sum, or so much thereof as
 19 may be necessary, respectively, for the object and purpose
 20 hereinafter named, is appropriated to the Illinois Arts Council
 21 to enhance the cultural environment in Illinois:

22 Payable from Illinois Arts Council Federal Grant Fund:

1 For Grants and Programs to Enhance
 2 the Cultural Environment and associated
 3 administrative costs75,000

4 Section 25. The sum of \$417,000, or so much thereof as may
 5 be necessary, is appropriated for a grant from the General
 6 Revenue Fund to the Illinois Arts Council to the Illinois
 7 Humanities Council.

8 Section 30. The sum of \$825,000, or so much thereof as may
 9 be necessary, is appropriated for a grant from the General
 10 Revenue Fund to the Illinois Arts Council for arts and foreign
 11 language programming in schools.

12 Section 35. The sum of \$375,000, or so much thereof as may
 13 be necessary, is appropriated from the General Revenue Fund to
 14 the Illinois Arts Council for administrative costs.

15 ARTICLE 2

16 Section 5. The sum of \$950,000, or so much thereof as may
 17 be necessary and remains unexpended at the close of business
 18 on June 30, 2022, from an appropriation heretofore made for
 19 such purpose in Article 70, Section 40 of Public Act 102-0017,
 20 as amended, is reappropriated from the Illinois Arts Council

1 Federal Grant Fund to the Illinois Arts Council, for grants to
2 support arts programs, services, and activities, and associated
3 administrative costs, including prior year costs.

4 Section 99. Effective Date. This Act takes effect July 1,
5 2022.
