Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Pension Code is amended by changing Section 11-196 and by adding Section 12-162.5 as follows:

- Sec. 11-196. To subpoen witnesses and compel the production of records. To issue subpoens to compel the attendance of witnesses to testify before it and to compel the production of documents and records upon any matter concerning the Fund, including, but not limited to, in conjunction with:
