

## 103RD GENERAL ASSEMBLY State of Illinois 2023 and 2024 HB2129

Introduced 2/7/2023, by Rep. Jennifer Gong-Gershowitz

## SYNOPSIS AS INTRODUCED:

55 ILCS 5/3-4007

from Ch. 34, par. 3-4007

Amends the Counties Code. Provides that a county's full-time public defender must be paid an annual salary that is at least 100% (rather than 90%) of the county State's attorney's annual compensation. Requires the State to pay 100% (rather than 66 2/3%) of the public defender's annual salary. Prohibits a public defender for a county of 30,000 or more inhabitants from engaging in the private practice of law if the public defender is receiving not less than 100% (rather than 90%) of the compensation of the State's attorney of that county. Effective July 1, 2023.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Counties Code is amended by changing Section 3-4007 as follows:
- 6 (55 ILCS 5/3-4007) (from Ch. 34, par. 3-4007)
- 7 Sec. 3-4007. Compensation.
- (a) The public defender shall be paid out of the county 8 9 treasury, and, subject to appropriation, shall be paid by the Department of Revenue out of the Personal Property Tax 10 Replacement Fund or the General Revenue Fund as provided in 11 12 subsection (b), as the sole compensation for his or her 13 services a salary in an amount fixed by the County Board. When 14 a Public Defender in a county of 30,000 or more population is receiving not less than 100% of the compensation of the 15 State's Attorney of such county, that Public Defender shall 16 17 not engage in the private practice of law.
- The State must pay 100%  $\frac{66}{2/3\%}$  of the public 18 19 defender's annual salary. If the public defender is employed full-time in that capacity, his or her salary must be at least 20 21 90% of that county's State's attorney's annual 100% 22 compensation. Subject to appropriation, these amounts furnished by the State shall be payable monthly by the 23

- 1 Department of Revenue out of the Personal Property Tax
- 2 Replacement Fund or the General Revenue Fund to the county in
- 3 which each Public Defender is employed.
- 4 (c) In cases where 2 or more adjoining counties have
- 5 joined to form a common office of Public Defender, the salary
- of the Public Defender shall be set and paid as provided by a
- 7 joint resolution of the various county boards involved.
