SYNOPSIS AS INTRODUCED:

625 ILCS 5/1-171	from Ch.	95 1/2,	par. 1-171

625 ILCS 5/3-413	from Ch.	95 1/2,	par. 3-413

Amends the Illinois Vehicle Code. Provides that, beginning with the next registration year after the effective date, the Secretary of State shall issue one registration plate (instead of 2) for newly registered motor vehicles and the registration plate shall be attached to the rear (instead of front and rear) of the motor vehicle.

AN ACT concerning transportation.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Illinois Vehicle Code is amended by 5 changing Sections 1-171, 3-412, and 3-413 as follows:

Sec. 1-171. Registration - Registration Sticker.
Registration. The registration certificate or certificates,
registration plates and registration stickers issued under the
laws of this State pertaining to the registration of vehicles.

11 Registration Sticker or Stickers. A device or devices to be attached to a rear registration plate that will renew the 12 13 registration and registration plate or plates for а 14 pre-determined period not to exceed one registration year except as provided in subsection (1) of Section 3-414 of this 15 16 Code. Should the Secretary of State determine it is advisable 17 to require a registration sticker to be attached to a front registration plate, he may require such action and provide the 18 19 necessary additional sticker. Such determination shall be 20 publicly announced at least 30 days in advance of a new annual 21 registration year.

General Assembly, the Secretary of State, upon registering a 1 2 vehicle subject to annual registration for the first time, 3 shall issue or shall cause to be issued to the owner one registration plate for a motorcycle, trailer, semitrailer, 4 motorized pedalcycle, or truck-tractor, one registration plate 5 for other motor vehicles, and, when applicable, current 6 registration stickers for motor vehicles of the first 7 8 division.

9 The provisions of this Section may be made applicable to 10 such vehicles of the second division, as the Secretary of 11 State may, from time to time, in his discretion designate. On 12 subsequent annual registrations during the term of the registration plate or digital registration plate as provided 13 14 in Section 3-414.1, the Secretary shall issue or cause to be issued registration stickers or digital registration stickers 15 16 as evidence of current registration. However, the issuance of 17 annual registration stickers or digital registration stickers to vehicles registered under the provisions of Sections 18 3-402.1 and 3-405.3 of this Code may not be required if the 19 20 Secretary deems the issuance unnecessary.

(b) Every registration plate or digital registration plate shall have displayed upon it the registration number assigned to the vehicle for which it is issued, the name of this State, which may be abbreviated, the year number for which it was issued, which may be abbreviated, the phrase "Land of Lincoln" (except as otherwise provided in this Code), and such other

letters or numbers as the Secretary may prescribe. However, 1 2 for apportionment plates issued to vehicles registered under 3 Section 3-402.1 and fleet plates issued to vehicles registered under Section 3-405.3, the phrase "Land of Lincoln" may be 4 5 omitted to allow for the word "apportioned", the word "fleet", or other similar language to be displayed. Registration plates 6 7 or digital registration plates issued to a vehicle registered 8 as a fleet vehicle may display a designation determined by the 9 Secretary.

10 The Secretary may in his discretion prescribe that letters 11 be used as prefixes only on registration plates or digital 12 registration plates issued to vehicles of the first division which are registered under this Code and only as suffixes on 13 registration plates or digital registration plates issued to 14 15 other vehicles. Every registration sticker or digital 16 registration sticker issued as evidence of current 17 registration shall designate the year number for which it is issued and such other letters or numbers as the Secretary may 18 19 prescribe and shall be of a contrasting color with the 20 registration plates or digital registration plates and 21 registration stickers or digital registration stickers of the 22 previous year.

(c) Each registration plate or digital registration plate and the required letters and numerals thereon, except the year number for which issued, shall be of sufficient size to be plainly readable from a distance of 100 feet during daylight,

and shall be coated with reflectorizing material. The
 dimensions of the plate issued to vehicles of the first
 division shall be 6 by 12 inches.

4 (d) The Secretary of State shall issue for every passenger 5 motor vehicle rented without a driver the same type of 6 registration plates or digital registration plates as the type 7 of plates issued for a private passenger vehicle.

8 (e) The Secretary of State shall issue for every passenger 9 car used as a taxicab or livery, distinctive registration 10 plates or digital registration plates.

11 (f) The Secretary of State shall issue for every 12 distinctive registration plates or motorcycle digital registration plates distinguishing between motorcycles having 13 150 or more cubic centimeters piston displacement, or having 14 15 less than 150 cubic centimeter piston displacement.

16 (g) Registration plates or digital registration plates 17 issued to vehicles for-hire may display a designation as 18 determined by the Secretary that such vehicles are for-hire.

(h) (Blank).

(i) The Secretary of State shall issue for every public 20 21 and private ambulance registration plates or digital 22 registration plates identifying the vehicle as an ambulance. 23 The Secretary shall forward to the Department of Healthcare and Family Services registration information for the purpose 24 of verification of claims filed with the Department by 25 26 ambulance owners for payment for services to public assistance

1 recipients.

2 (j) The Secretary of State shall issue for every public and private medical carrier or rescue vehicle 3 livery registration plates or digital registration plates displaying 4 5 numbers within ranges of numbers reserved respectively for medical carriers and rescue vehicles. The Secretary shall 6 forward to the Department of Healthcare and Family Services 7 8 registration information for the purpose of verification of 9 claims filed with the Department by owners of medical carriers 10 or rescue vehicles for payment for services to public 11 assistance recipients.

(k) The Secretary of State shall issue distinctive license 12 13 plates or digital registration plates or distinctive license plate stickers or digital registration stickers for every 14 15 vehicle exempted from subsections (a) and (a-5) of Section 12-503 by subsection (g) of that Section, and by subsection 16 17 (g-5) of that Section before its deletion by this amendatory Act of the 95th General Assembly. The Secretary shall issue 18 19 these plates or stickers immediately upon receiving the 20 physician's certification required under subsection (q) of Section 12-503. New plates or stickers shall also be issued 21 22 when the certification is renewed as provided in that 23 subsection.

(1) The Secretary of State shall issue distinctive
 registration plates or digital registration plates for
 low-speed vehicles.

1 (m) The Secretary of State shall issue distinctive 2 registration plates or digital registration plates for 3 autocycles. The dimensions of the plate issued to autocycles 4 shall be 4 by 7 inches.

Sec. 3-413. Display of registration plates or digital
registration plates, registration stickers or digital
registration stickers, and drive-away permits; registration
plate or digital registration plate covers.

11 (a) Registration plates or digital registration plates 12 issued for a motor vehicle other than a motorcycle, autocycle, trailer, semitrailer, truck-tractor, apportioned bus, or 13 14 apportioned truck shall be attached thereto, one in the front 15 and one in the rear. Beginning with the next registration year 16 after the effective date of this amendatory Act of the 103rd General Assembly, the registration plate issued for a motor 17 vehicle other than a motorcycle, trailer, semitrailer, 18 truck-tractor, apportioned bus, or apportioned truck shall be 19 20 attached to the rear of the vehicle.

The registration plate or digital registration plate issued for a motorcycle, autocycle, trailer or semitrailer required to be registered hereunder and any apportionment plate issued to a bus under the provisions of this Code shall be attached to the rear thereof. The registration plate or digital registration plate issued for a truck-tractor or an apportioned truck required to be registered hereunder shall be attached to the front thereof.

Except for vehicles with rear loaded motorized 4 (b) 5 forklifts, every registration plate or digital registration plate shall at all times be securely fastened in a horizontal 6 7 position to the vehicle for which it is issued so as to prevent 8 the plate from swinging and at a height of not less than 5 9 inches from the ground, measuring from the bottom of such 10 plate, in a place and position to be clearly visible and shall 11 be maintained in a condition to be clearly legible, free from 12 any materials that would obstruct the visibility of the plate. A registration plate or digital registration plate on a 13 14 motorcycle may be mounted vertically as long as it is 15 otherwise clearly visible. Registration stickers or digital 16 registration stickers issued as evidence of renewed annual 17 registration shall be attached to registration plates or displayed on digital registration plates as required by the 18 Secretary of State, and be clearly visible at all times. For 19 those vehicles with rear loaded motorized forklifts, if the 20 rear plate is securely fastened in a horizontal position as 21 22 prescribed, the plate and registration sticker shall not be 23 required to be clearly visible at all times as a result of the rear mounted motorized forklift obstructing the view. 24

(c) Every drive-away permit issued pursuant to this Codeshall be firmly attached to the motor vehicle in the manner

prescribed by the Secretary of State. If a drive-away permit is affixed to a motor vehicle in any other manner the permit shall be void and of no effect.

4 (d) The Illinois prorate decal issued to a foreign 5 registered vehicle part of a fleet prorated or apportioned 6 with Illinois, shall be displayed on a registration plate or 7 digital registration plate and displayed on the front of such 8 vehicle in the same manner as an Illinois registration plate 9 or digital registration plate.

10 (e) The registration plate or digital registration plate 11 issued for a camper body mounted on a truck displaying 12 registration plates or digital registration plates shall be 13 attached to the rear of the camper body.

(f) No person shall operate a vehicle, nor permit the 14 15 operation of a vehicle, upon which is displayed an Illinois 16 registration plate or plates or digital registration plate or 17 plates or registration stickers or digital registration stickers, except as provided for in subsection (b) of Section 18 3-701 of this Code, after the termination of the registration 19 20 period for which issued or after the expiration date set pursuant to Sections 3-414 and 3-414.1 of this Code. 21

(g) A person may not operate any motor vehicle that is equipped with registration plate or digital registration plate covers. A violation of this subsection (g) or a similar provision of a local ordinance is an offense against laws and ordinances regulating the movement of traffic.

(h) A person may not sell or offer for sale a registration
 plate or digital registration plate cover. A violation of this
 subsection (h) is a business offense.

4 (i) A person may not advertise for the purpose of 5 promoting the sale of registration plate or digital 6 registration plate covers. A violation of this subsection (i) 7 is a business offense.

(j) A person may not modify the original manufacturer's 8 9 mounting location of the rear registration plate or digital 10 registration plate on any vehicle so as to conceal the 11 registration or to knowingly cause it to be obstructed in an 12 effort to hinder a peace officer from obtaining the 13 registration for the enforcement of a violation of this Code, Section 27.1 of the Toll Highway Act concerning toll evasion, 14 or any municipal ordinance. Modifications prohibited by this 15 16 subsection (j) include but are not limited to the use of an 17 electronic device. A violation of this subsection (j) is a Class A misdemeanor. 18
