1 AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1

Section 5. The sum of \$7,000,000, or so much thereof as may be necessary, is appropriated to the Illinois Student Assistance Commission from the General Revenue Fund to meet its operational expenses for the fiscal year ending June 30, 2024.

Section 10. The following named amount, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Illinois Student Assistance Commission for the following purpose:

To support outreach, research, and

Section 15. The sum of \$401,566,200, or so much thereof as may be necessary, is appropriated to the Illinois Student Assistance Commission from the General Revenue Fund for grant awards to students eligible for the Monetary Award Program, as provided by law, and for agency administrative and operational costs not to exceed 2 percent of the total appropriation in

- 1 this Section.
- Section 20. The sum of \$300,000,000, or so much thereof as may be necessary, is appropriated to the Illinois Student Assistance Commission from the Education Assistance Fund for grant awards to students eligible for the Monetary Award Program, as provided by law, and for agency administrative and operational costs not to exceed 2 percent of the total appropriation in this Section.
- 9 Section 25. The sum of \$35,000,000, or so much thereof as
 10 may be necessary, is appropriated to the Illinois Student
 11 Assistance Commission from the General Revenue Fund for
 12 payments to eligible public universities for grants to students
 13 pursuant to the AIM HIGH program.
- Section 30. The sum of \$150,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Illinois Student Assistance Commission for costs associated with providing grants to exonerated persons, as provided by law.
- Section 35. The sum of \$26,400, or so much thereof as may be necessary, is appropriated from the Education Assistance Fund to the Illinois Student Assistance Commission for costs

- 1 associated with the Veterans' Home Medical Providers' Loan
- 2 Repayment Program pursuant to Public Act 99-0813.
- 3 Section 40. The sum of \$500,000, or so much thereof as may
- 4 be necessary, is appropriated from the Education Assistance

Section 100. The sum of \$1,500,000, or so much thereof as
may be necessary, is appropriated to the Illinois Student
Assistance Commission from the Student Loan Operating Fund for
costs associated with Federal Loan System Development and
Maintenance.

Section 105. The sum of \$1,000,000 or so much thereof as may be necessary, is appropriated to the Illinois Student Assistance Commission from the Student Loan Operating Fund for costs associated with the Illinois Designated Account Purchase Program.

Section 110. The following named sum, or so much thereof as may be necessary, is appropriated from the Federal Congressional Teacher Scholarship Program Fund to the Illinois Student Assistance Commission for the following purpose:

For transferring repayment funds collected

- 1 under the Paul Douglas Teacher Scholarship
- Section 115. The sum of \$50,000,000, or so much thereof 3 as may be necessary, is appropriated from the Federal Student 4 5 Loan Fund to the Illinois Student Assistance Commission for distribution when necessary as a result of the following: for 6 quarantees of loans that are uncollectible, for collection 7 8 payments to the Student Loan Operating Fund as required under 9 agreements with the United States Secretary of Education, for 10 payment to the Student Loan Operating Fund for Default Aversion Fees, for transfers to the U.S. Treasury, or for other 11 12 distributions as necessary and provided for under the Federal 13 Higher Education Act.
- Section 120. The sum of \$13,000,000, or so much thereof
 as may be necessary, is appropriated from the Federal Student
 Incentive Trust Fund to the Illinois Student Assistance
 Commission for allowable uses of federal grant funds related
 to college access, outreach, and training, including but not
 limited to funds received under the federal Gaining Early
 Awareness and Readiness for Undergraduate Program.
- Section 125. The sum of \$300,000, or so much thereof as 22 may be necessary, is appropriated from the Federal Student

- 1 Incentive Trust Fund to the Illinois Student Assistance
- 2 Commission for the John R. Justice Student Loan Repayment
- 3 Program.
- 4 Section 130. The sum of \$114,000,000, or so much thereof
- 5 as may be necessary, is appropriated from the Student Loan
- 6 Operating Fund to the Illinois Student Assistance Commission
- 7 for financial assistance and administrative costs associated
- 8 with early childhood programs.
- 9 Section 135. The sum of \$4,000,000, or so much thereof as
- 10 may be necessary, is appropriated from the Nursing Dedicated
- 11 and Professional Fund to the Illinois Student Assistance
- 12 Commission for expenses related to the Nursing Education
- 13 Scholarship Law.
- 14 Section 140. The sum of \$1,100,000, or so much thereof as
- may be necessary, is appropriated from the Energy Transition
- 16 Assistance Fund to the Illinois Student Assistance Commission
- 17 for costs associated with providing grants to eligible
- individuals, for costs pursuant to the Energy Transition Act.
- 19 Section 145. The sum of \$6,000,000, or so much thereof as
- 20 may be necessary, is appropriated from the General Revenue Fund
- 21 to the Illinois Student Assistance Commission for costs

1 associated with Social Worker Scholarships and loan repayment

2 assistance.

3 ARTICLE 2

Section 5. The sum of \$3,280,045, or so much thereof as may be necessary and remains unexpended at the close of business on June 30, 2023, from an appropriation heretofore made for such purpose in Article 138, Section 400 of Public Act 102-0698, as amended, is reappropriated from the State Coronavirus Urgent Remediation Emergency Fund to the Illinois Student Assistance Commission for the Golden Apple Scholars of Illinois Program, for purposes permitted by Section 9901 of the American Rescue Plan Act of 2021 and related federal guidance.

Section 10. The sum of \$3,492,690, or so much thereof as may be necessary and remains unexpended at the close of business on June 30, 2023, from an appropriation heretofore made for such purpose in Article 138, Section 405 of Public Act 102-0698, as amended, is reappropriated from the State Coronavirus Urgent Remediation Emergency Fund to the Illinois Student Assistance Commission for the Golden Apple Accelerators Program, for purposes permitted by Section 9901 of the American Rescue Plan Act of 2021 and related federal guidance.
