Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 10. The sum of \$4,000,000, or so much thereof as may be necessary, is appropriated from the State Asset Forfeiture Fund to the Illinois State Police for payment of their expenditures as outlined in the Illinois Drug Asset Forfeiture Procedure Act, the Cannabis Control Act, the

Controlled Substances Act and the Environmental Safety Act.

Section 15. The sum of \$2,500,000, or so much thereof as may be necessary, is appropriated from the Federal Asset Forfeiture Fund to the Illinois State Police for payment of their expenditures in accordance with the Federal Equitable Sharing Guidelines.

Section 20. The sum of \$2,000,000, or so much thereof as may be necessary, is appropriated to the Illinois State Police, Division of Justice Services, from the Money Laundering Asset Recovery Fund for the ordinary and contingent expenses incurred by the Illinois State Police.

Section 25. The sum of \$1,000,000, or so much thereof as

- 9 Operations, for the detection, investigation or prosecution of
- 10 recipient or vendor fraud.
- 11 Section 55. The sum of \$13,000,000, or so much thereof as

- 15 program for the Illinois State Police.
- 16 Section 60. The sum of \$2,000,000, or so much thereof as

16	Section 85. The sum of \$29,000,000, or so much thereof as

19	outlined in the Firearm Concealed Carry Act and the Firearm
20	Owners Identification Card Act.
21	Section 90. The sum of \$500,000, or so much thereof as may
22	be necessary, is appropriated to the Illinois State Police from

- 1 the Illinois State Police Firearm Services Fund to provide
- 2 logistical and administrative assistance to the Firearm Owner's
- 3 Identification Card Review Board.
- 4 Section 95. The sum of \$230,000,000, or so much thereof
- 5 as may be necessary, is appropriated from the Statewide 9-1-1
- 6 Fund to the Illinois State Police, Division of Justice
- 7 Services, for costs pursuant to the Emergency Telephone System
- 8 Act.
- 9 Section 100. The sum of \$2,000,000, or so much thereof as
- 10 may be necessary, is appropriated from the State Police
- 11 Revocation Enforcement Fund to the Illinois State Police, for
- 12 grants to law enforcement agency task forces for participating
- in programs to help reduce crime
- Section 105. The sum of \$1,300,000, or so much thereof as
- may be necessary, is appropriated from the General Revenue Fund
- 16 to the Illinois State Police, for the ordinary and contingent
- 17 expenses of the Safe2Help Program.
- 18 Section 99. Effective date. This Act takes effect July 1,
- 19 2023.
