A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much thereof  
6 as may be necessary, respectively, for the objects and purposes  
7 hereinafter named, are appropriated from the General Revenue  
8 Fund to the Department of Veterans' Affairs:

 7 be necessary, is appropriated from the General Revenue Fund to  
 8 the Department of Veterans' Affairs for all costs associated  
 9 with the Veterans' Accountability Unit.

10 Section 10. The following named amounts, or so much thereof  
 11 as may be necessary, are appropriated from the General Revenue  
 12 Fund to the Department of Veterans' Affairs for the objects and  
 13 purposes and in the amounts set forth as follows:

21 Section 15. The sum of \$3,500,000, or so much thereof as  
 22 may be necessary, is appropriated from the General Revenue Fund

1 scholarships to students who are dependents of Illinois  
 2 resident military personnel declared to be prisoners of war,  
 3 missing in action, killed or permanently disabled, as provided  
 4 by law.

5 Section 20. The following named amount, or so much thereof  
 6 as may be necessary, is appropriated from the General Revenue  
 7 Fund to the Department of Veterans' Affairs for the object and  
 8 purpose and in the amount set forth below as follows:

9 For Cartage and Erection of Veterans'  
 10 Headstones, including Prior Years Claims .....425,000

11 Section 25. The amount of \$250,000, or so much thereof as  
 12 may be necessary, is appropriated from the General Revenue Fund  
 13 to the Department of Veterans' Affairs for costs associated  
 14 with the Illinois Warrior Assistance Program.

15 Section 30. The amount of \$27,030,900, or so much thereof  
 16 as may be necessary, is appropriated from the General Revenue  
 17 Fund to the Department of Veterans' Affairs for costs  
 18 associated with the Illinois Veterans' Home at Chicago.

19 Section 31. The amount of \$1,500,000, or so much thereof  
 20 as may be necessary, is appropriated from the Illinois Veterans  
 21 Home Fund to the Department of Veterans' Affairs for costs

1 associated with the Chicago Veterans' Home.

2 Section 35. The amount of \$2,000,000, or so much thereof  
3 as may be necessary, is appropriated from the Illinois Veterans  
4 Assistance Fund to the Department of Veterans' Affairs for  
5 making grants, funding additional services, or conducting  
6 additional research projects relating to veterans' post  
7 traumatic stress disorder; veterans' homelessness; the health  
8 insurance cost of veterans; veterans' disability benefits,  
9 including but not limited to, disability benefits provided by  
10 veterans service organizations and veterans assistance  
11 commissions or centers; and the long-term care of veterans.

12 Section 40. The following named amount, or so much thereof  
13 as may be necessary, is appropriated from the Illinois  
14 Affordable Housing Trust Fund to the Department of Veterans'  
15 Affairs for the object and purpose and in the amount set forth  
16 as follows:

17 For Specially Adapted Housing for Veterans .....240,000

18 Section 45. The amount of \$250,000, or so much thereof as  
19 may be necessary, is appropriated from the Illinois Military  
20 Family Relief Fund to the Department of Veterans' Affairs for  
21 the payment of benefits authorized under the Survivor's  
22 Compensation Act.

6           may be necessary, is appropriated from the Folds Of Honor  
7           Foundation Fund to the Department of Veterans' Affairs for  
8           grants to aid in providing educational scholarships to military  
9           families.

10          Section 90. The sum of \$1,250,000, or so much thereof as  
11          may be necessary, is appropriated from the General Revenue Fund  
12          to the Department of Veterans' Affairs for expenses related to  
13          the security and safety enhancements at all five Illinois  
14          Veterans' Homes.

15          Section 95. The sum of \$500,000, or so much thereof as may  
16          be necessary, is appropriated from the General Revenue Fund to  
17          the Department of Veterans' Affairs for expenses related to  
18          Diversity, Equity, Inclusion and Accessibility (DEIA) goals.

19          Section 99. Effective date. This Act takes effect July 1,  
20          2023.
