## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Insurance Code is amended by changing Sections 155.22 and 424 and by adding Section 143.13b as follows:

- Sec. 143.13b. Coverage for motor vehicle theft. Any policy
  of automobile insurance that carries comprehensive coverage
  may not exclude theft coverage for lack of evidence of
  forcible entry or for the insured leaving the vehicle unlocked
- or leaving a key or key fob in the motor vehicle.

- Sec. 155.22. No company authorized to transact in this 14 15 State the kinds of business described in Classes 2 and 3 of Section 4, and no officer, director, agent, clerk, employee or 16 broker of such company shall upon proper application refuse to 17 18 provide insurance solely on the basis of the specific geographic location of the risk sought to be insured unless 19 20 such refusal is for a business purpose which is not a mere 21 pretext for unfair discrimination.

Sec. 424. Unfair methods of competition and unfair or deceptive acts or practices defined. The following are hereby defined as unfair methods of competition and unfair and deceptive acts or practices in the business of insurance:

- (1) The commission by any person of any one or more of the acts defined or prohibited by Sections 134, 143.24c, 147, 148, 149, 151, 155.22, 155.22a, 155.42, 236, 237, 364, 469, and 513b1 of this Code.
- (2) Entering into any agreement to commit, or by any concerted action committing, any act of boycott, coercion or intimidation resulting in or tending to result in unreasonable restraint of, or monopoly in, the business of insurance.
- (3) Making or permitting, in the case of insurance of the types enumerated in Classes 1, 2, and 3 of Section 4, any unfair discrimination between individuals or risks of the same class or of essentially the same hazard and expense element because of the race, color, religion, or national origin, or geographic location of such insurance risks or applicants. The application of this Article to the types of insurance enumerated in Class 1 of Section 4 shall in no way limit, reduce, or impair the protections and remedies already provided for by Sections 236 and 364 of this Code or any other provision of this Code.

- (4) Engaging in any of the acts or practices defined 1 2 in or prohibited by Sections 154.5 through 154.8 of this Code. 3
  - (5) Making or charging any rate for insurance against losses arising from the use or ownership of a motor vehicle which requires a higher premium of any person by reason of his physical disability, race, color, religion, or national origin.
  - (6) Failing to meet any requirement of the Unclaimed Life Insurance Benefits Act with such frequency as to constitute a general business practice.
