SYNOPSIS AS INTRODUCED:

35 ILCS 5/234 new

Amends the Illinois Income Tax Act. Creates an income tax credit for community based faculty preceptors. Sets forth the amount of the credit. Effective immediately.

AN ACT concerning revenue.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The Illinois Income Tax Act is amended by 5 adding Section 234 as follows:

6 (35 ILCS 5/234 new)

- 7 <u>Sec. 234. Preceptor credit.</u>
- 8 (a) As used in this Section:
- 9 <u>Advanced practice registered nurse student" means an</u> 10 <u>individual participating in a training program in this State</u> 11 <u>that is accredited by a nationally recognized accrediting body</u> 12 <u>for advanced practice registered nursing programs for the</u> 13 <u>training of individuals to become advanced practice registered</u> 14 <u>nurses as defined in the Nurse Practice Act.</u>

15 "Community based faculty preceptor" means an individual 16 who is a physician licensed to practice medicine in all its 17 branches, an advanced practice registered nurse licensed under 18 the Nurse Practice Act, or a physician assistant who is 19 licensed as such by the State.

20 <u>"Medical student" means an individual participating in a</u> 21 <u>training program in this State that is approved by the</u> 22 <u>Illinois Medical Board for the training of doctors of medicine</u> 23 <u>or doctors of osteopathic medicine.</u> 1 <u>"Physician assistant student" means an individual</u>
2 participating in a training program in this state that is
3 approved by the Illinois Department of Financial and
4 Professional Regulation for the training of individuals to
5 become physician assistants.

6 <u>"Preceptorship rotation" means a period of preceptorship</u> 7 <u>training of one or more medical students, physician assistant</u> 8 <u>students, or advanced practice registered nurse students that,</u> 9 <u>in aggregate, totals the number of hours per rotation</u> 10 <u>necessitated by the statute, rule, or accrediting body</u> 11 governing the student's program rotations.

12 <u>"Preceptorship training" means uncompensated community</u> 13 <u>based training of a medical student, advanced practice</u> 14 <u>registered nurse student, or physician assistant student</u> 15 <u>matriculating in a training program in Illinois.</u>

16 (b) For taxable years beginning on or after January 1, 2024, each community based faculty preceptor shall be allowed a credit against the tax imposed by subsections (a) and (b) of Section 201 if he or she conducts a preceptorship rotation during the taxable year. Such credit shall be accrued on a per preceptorship rotation basis. The amount of the credit shall be as following:

(1) if the community based faculty preceptor is a
 physician, then \$500 for the first, second, or third
 preceptorship rotation completed during the calendar year
 and \$1,000 for the fourth, fifth, sixth, seventh, eighth,

1 ninth, or tenth preceptorship rotations completed during 2 the calendar year; or 3 (2) if the community based faculty preceptor is an 4 advanced practice registered nurse, then \$375 for the 5 first, second, or third preceptorship rotation completed during the calendar year and \$750 for the fourth, fifth, 6 sixth, seventh, eighth, ninth, or tenth preceptorship 7 8 rotations completed during the calendar year. 9 An individual shall not accrue credit for more than 10 10 preceptorship rotations in one calendar year. 11 (c) A community based faculty preceptor shall not be 12 eligible to earn hours credited toward preceptorship training if he or she has not registered with the Illinois Area Health 13 14 Education Centers in Rockford, Illinois. (d) To receive the credit allowed by this Section, a 15 16 community based faculty preceptor shall claim the credit on 17 his or her return for the tax year in which he or she completed the preceptorship rotation, shall certify that he or she did 18 19 not receive payment during the tax year from any source for the 20 training of a medical student, advanced practice registered 21 nurse student, or physician assistant student if she received 22 a credit for a preceptorship rotation with respect to that 23 student, and shall submit supporting documentation as 24 prescribed by the Secretary of Financial and Professional 25 Regulation. 26 (e) In no event shall the total amount of the tax credit
