This Act is intended to provide time off 12 with pay to allow employees of units of local government, boards of election commissioners, or private employers in the 13 14 State of Illinois to donate blood or an organ. - Sec. 5. Definitions. As used in this Act:
- 3 "Employer" means any unit of local government, board of
- 4 election commissioners, or any private employer in the State
- who has 51 or more employees. 5
- "Department" means the Department of Public Health. 6
- 7 "Organ" means any biological tissue of the human body that
- 8 may be donated by a living donor, including, but not limited
- 9 to, the kidney, liver, lung, pancreas, intestine, bone, and
- 10 skin or any subpart thereof.
- "Participating employee" means a full-time employee who 11
- 12 has been employed by an employer for a period of 6 months or
- more and who donates blood or an organ. 13

- Sec. 10. Paid leave for blood donation; administration. 16
- 17 (a) On request, a participating employee subject to this
- Act may be entitled to blood donation leave with pay to donate 18
- blood or an organ. 19
- 20 (b) An employee may use up to one hour, or more if
- 21 authorized by the employer or a collective bargaining
- 22 agreement, to donate blood every 56 days in accordance with
- 23 appropriate medical standards established by the American Red
- 24 Cross, America's Blood Centers, the American Association of

- 1 Blood Banks, or other nationally recognized standards.
- 2 (b-5) An employee may use up to 10 days of leave in any
- 12-month period to serve as an organ donor. 3
- 4 (c) A participating employee may use the leave authorized
- 5 in subsection (b) or (b-5) of this Section only after
- 6 obtaining approval from the employer.
- 7 (d) The Department must adopt rules governing blood
- donation leave taken to donate blood or an organ, including 8
- 9 rules that (i) establish conditions and procedures for
- 10 requesting and approving leave and (ii) require medical
- documentation of the proposed blood or organ donation before 11
- 12 leave is approved by the employer.
