SYNOPSIS AS INTRODUCED:

225 ILCS 10/7.10

Amends the Child Care Act of 1969. Provides that the Department of Children and Family Services shall host licensing orientation programs to help educate potential day care center, day care home, and group day care home providers about the child day care licensing process. Provides that the Department shall host licensing orientation programs at least twice annually in each legislative district in the State.

1 AN ACT concerning regulation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 5. The Child Care Act of 1969 is amended by
- 5 changing Section 7.10 as follows:
- 6 (225 ILCS 10/7.10)
- Sec. 7.10. <u>Licensing orientation program and progress</u>
- 8 Progress report.
- 9 (a) For the purposes of this Section, "child day care
- 10 licensing" or "day care licensing" means licensing of day care
- 11 centers, day care homes, and group day care homes.
- 12 <u>(a-5) The Department shall host licensing orientation</u>
- programs to help educate potential day care center, day care
- 14 home, and group day care home providers about the child day
- 15 care licensing process. The Department shall host licensing
- 16 <u>orientation programs at least twice annually in each</u>
- 17 <u>legislative district in the State.</u>
- 18 (b) No later than September 30th of each year, the
- 19 Department shall provide the General Assembly with a
- 20 comprehensive report on its progress in meeting performance
- 21 measures and goals related to child day care licensing.
