Upon receipt of a request of a member of the General Assembly, accompanied by 17 the appropriate application and fee, the Secretary of State 18 19 shall issue to the member 2 plates as described in this 20 Section. The special plates issued under this Section shall be 21 affixed only to passenger vehicles of the first division, 22 motorcycles, and motor vehicles of the second division weighing not more than 8,000 pounds. Except as otherwise 23

provided in this Section, if the member so requests, the 1 2 Secretary shall issue 2 sets of such registration plates for 3 use on 2 different motor vehicles. A member may request that the Secretary of State issue registration plates in the name 4 5 of a corporation when the corporation owns or leases the vehicle to be registered and the member is an officer or 6 director of that corporation. Such registration plates shall 7 8 be issued for a 2-year period beginning January 1 of each 9 odd-numbered year and ending December 31 of the subsequent 10 even-numbered year. If the application is from a member of the 11 Senate, there shall appear on the rear plate, in addition to 12 the designation of the State and the year for which the license was issued, the word "official" and appropriate wording or 13 14 abbreviation indicating that the holder is a member of the 15 Senate, followed by the number of the senatorial district of 16 the member. On the front plate, there shall appear appropriate 17 wording or abbreviation indicating that the holder is a member of the Senate. If the application is from a member of the House 18 19 of Representatives, there shall appear on the rear plate, in 20 addition to the designation of the State and the year for which the license was issued, the word "official" and appropriate 21 22 wording or abbreviation indicating that the holder is a member 23 of the House of Representatives, followed by the number 24 assigned to the member. On the front plate, there shall appear 25 appropriate wording or abbreviation indicating that the holder 26 is a member of the House of Representatives. 1 118 shall be assigned and members with the longest length of 2 service as members of the legislature shall be given the lower 3 numbers.

When members have an equal length of service, the lower numbers shall be given in alphabetical order based on surnames.

7 A member of the General Assembly who has a disability as 8 defined under Section 1-159.1 may request one set of 9 specialized plates which display the International Symbol of 10 Access and shall be subject to the provisions within Section 11 3-616. The set of specialized plates displaying the 12 International Symbol of Access shall only be issued along with the assignment of a corresponding disability placard that must 13 be displayed in the vehicle. The surviving spouse of the 14 15 member shall not be entitled to retain this plate.

The special plates issued under this 13 Section shall be affixed only to passenger vehicles of the 14 15 first division, motorcycles, and motor vehicles of the second 16 division weighing not more than 8,000 pounds. Such plates may be issued for a 2-year period beginning on January 1 of each 17 odd-numbered year and ending on December 31 of the subsequent 18 even-numbered year. The special plates issued under 20 21 this Section shall be affixed only to passenger vehicles of 22 the first division, motorcycles, or motor vehicles of the second division weighing not more than 8,000 pounds, owned by 23 the fire department or the fire chief, deputy fire chief, or 24 25 assistant fire chief of the fire department. The Secretary 6 7 may prescribe rules governing the requirements and approval of 8 the special plates. The fee for this plate for a vehicle owned 9 by the fire chief, deputy fire chief, or assistant fire chief 10 shall be the same as the fee prescribed for first division 11 vehicles in Section 3-806 of this Code. 3 (a) Upon receiving an application for a certificate of 4 registration for a motor vehicle of the first division, a 5 motorcycle, or for a motor vehicle of the second division 6 weighing no more than 8,000 pounds, accompanied with payment 7 of the registration fees required under this Code from a person with disabilities or a person who is deaf or hard of 8 9 hearing, the Secretary of State, if so requested, shall issue 10 to such person registration plates as provided for in Section 11 3-611, provided that the person with disabilities or person who is deaf or hard of hearing must not be disgualified from 12 obtaining a driver's license under subsection 8 of Section 13 14 6-103 of this Code, and further provided that any person 15 making such a request must submit a statement, certified by a 16 licensed physician, by a licensed physician assistant, or by a licensed advanced practice registered nurse, to the effect 17 18 that such person is a person with disabilities as defined by Section 1-159.1 of this Code, or alternatively provide 19 adequate documentation that such person has a Class 1A, Class 20 21 2A or Type Four disability under the provisions of Section 4A 22 of the Illinois Identification Card Act. For purposes of this Section, an Illinois Person with a Disability Identification 23 24 Card issued pursuant to the Illinois Identification Card Act 25 indicating that the person thereon named has a disability

shall be adequate documentation of such a disability.

(b) The Secretary shall issue plates under this Section to 2 3 a parent or legal guardian of a person with disabilities if the person with disabilities has a Class 1A or Class 2A disability 4 5 as defined in Section 4A of the Illinois Identification Card Act or is a person with disabilities as defined by Section 6 1-159.1 of this Code, and does not possess a vehicle 7 8 registered in his or her name, provided that the person with 9 disabilities relies frequently on the parent or legal quardian 10 for transportation. Only one vehicle per family may be 11 registered under this subsection, unless the applicant can 12 justify in writing the need for one additional set of plates. Any person requesting special plates under this subsection 13 14 shall submit such documentation or such physician's, physician 15 assistant's, or advanced practice registered nurse's statement 16 as is required in subsection (a) and a statement describing 17 the circumstances qualifying for issuance of special plates under this subsection. An optometrist may certify a Class 2A 18 Visual Disability, as defined in Section 4A of the Illinois 19 20 Identification Card Act, for the purpose of qualifying a 21 person with disabilities for special plates under this 22 subsection.

(c) The Secretary may issue a parking decal or device to a person with disabilities as defined by Section 1-159.1 without regard to qualification of such person with disabilities for a driver's license or registration of a vehicle by such person HB4966 Engrossed - 15 - LRB103 36373 MXP 66472 b

with disabilities or such person's immediate family, provided 1 2 such person with disabilities making such a request has been 3 issued an Illinois Person with a Disability Identification Card indicating that the person named thereon has a Class 1A or 4 5 Class 2A disability, or alternatively, submits a statement certified by a licensed physician, or by a licensed physician 6 7 assistant or a licensed advanced practice registered nurse as 8 provided in subsection (a), to the effect that such person is a 9 person with disabilities as defined by Section 1-159.1. An 10 optometrist may certify a Class 2A Visual Disability as 11 defined in Section 4A of the Illinois Identification Card Act 12 for the purpose of qualifying a person with disabilities for a parking decal or device under this subsection. 13

(d) The Secretary shall prescribe by rules and regulations 14 15 procedures to certify or re-certify as necessary the 16 eligibility of persons whose disabilities are other than 17 permanent for special plates or parking decals or devices issued under subsections (a), (b) and (c). Except as provided 18 19 under subsection (f) of this Section, no such special plates, 20 decals or devices shall be issued by the Secretary of State to or on behalf of any person with disabilities unless such 21 22 person is certified as meeting the definition of a person with 23 disabilities pursuant to Section 1-159.1 or meeting the 24 requirement of a Type Four disability as provided under 25 Section 4A of the Illinois Identification Card Act for the 26 period of time that the physician, or the physician assistant

8 (f) The Secretary of State, upon application, shall issue 9 disability registration plates or a parking decal to 10 corporations, school districts, State or municipal agencies, 11 limited liability companies, nursing homes, convalescent 12 homes, or special education cooperatives which will transport 13 persons with disabilities. The Secretary shall prescribe by 14 rule a means to certify or re-certify the eligibility of 15 organizations to receive disability plates or decals and to 16 designate which of the 2 person with disabilities emblems 17 shall be placed on gualifying vehicles.

(g) The Secretary of State, or his designee, may enter 18 into agreements with other jurisdictions, including foreign 19 20 jurisdictions, on behalf of this State relating to the extension of parking privileges by such jurisdictions to 21 22 residents of this State with disabilities who display a 23 special license plate or parking device that contains the International symbol of access on his or her motor vehicle, 24 25 and to recognize such plates or devices issued by such other 26 jurisdictions. The special plates issued under this Section 16 shall be affixed only to passenger vehicles of the first division, motorcycles, motor vehicles of the second division 17 18 weighing not more than 8,000 pounds, and, as of January 1, 1996, recreational vehicles as defined by Section 1-169 of 19 20 this Code. Plates issued under this Section shall expire 21 according to the multi-year procedure established by Section 22 3-414.1 of this Code.

(b) The design and color of the plates shall be wholly
within the discretion of the Secretary of State. Appropriate
documentation, as determined by the Secretary, shall accompany

Of this fee, \$25 shall be deposited into the State 8 Parks Fund and \$15 shall be deposited into the Secretary of 9 State Special License Plate Fund, to be used by the Secretary 10 of State to help defray the administrative processing costs. 11 For each registration renewal period, a \$27 fee, in addition 12 to the appropriate registration fee, shall be charged. (a) In addition to any other special license plate, the
Secretary, upon receipt of all applicable fees and
applications made in the form prescribed by the Secretary of
State, may issue collegiate license plates. The collegiate
plates issued under this Section shall be affixed only to
passenger vehicles of the first division, motorcycles, and

motor vehicles of the second division weighing not more than 8,000 pounds and subject to the staggered registration system. Plates issued under this Section shall expire according to the staggered multi-year procedure established under Section 3-414.1 of this Code.

6 (b) The design, color, and format of the plates shall be 7 wholly within the discretion of the Secretary of State. The 8 Secretary of State may, at his or her discretion, issue the 9 plates for any public college or university located in this 10 State or for any degree-granting, not-for-profit private 11 college or university located in this State or a contiguous 12 state. If the college or university is located in a contiguous state, there must be not less than 10,000 alumni of the college 13 14 or university residing in this State. The Secretary may, in 15 his or her discretion, allow the plates to be issued as vanity 16 plates or personalized in accordance with Section 3-405.1 of 17 this Code.
