11 Department of Transportation for costs associated with Illinois  
12 Terrorism Task Force, that consist of approved purchases for  
13 homeland security provided such expenditures do not exceed  
14 funds made available by the federal government for this  
15 purpose.

16 Section 80. The sum of \$300,000, or so much thereof as may  
17 be necessary, is appropriated from the Road Fund to the  
18 Department of Transportation for costs incurred by the  
19 Department's response to natural disasters, emergencies and  
20 acts of terrorism that receive Presidential and/or State  
21 Disaster Declaration status. These costs would include, but  
22 not be limited to, the Department's fuel costs, cost of

1 materials and cost of equipment rentals. This appropriation  
2 is in addition to the Department's other appropriations for  
3 District and Central Office operations.

4 Section 85. The sum of \$210,000, or so much thereof as may  
5 be necessary, is appropriated from the Road Fund to the  
6 Department of Transportation for costs associated with the  
7 Technology Transfer Center, including the purchase of  
8 equipment, media initiatives, and training, provided that such  
9 expenditures do not exceed funds to be made available by the  
10 federal government for this purpose.

11 Section 90. The sum of \$5,500,000, or so much thereof as  
12 may be necessary, is appropriated from the Road Fund to the  
13 Department of Transportation for costs associated with highway  
14 safety media campaigns, provided such amounts do not exceed  
15 funds to be made available from the federal government.

16 Section 95. The sum of \$10,300,000, or so much thereof as  
17 may be necessary, is appropriated from the Road Fund to the  
18 Department of Transportation for the IDOT ITS Program.

19 Section 100. The sum of \$160,000, or so much thereof as  
20 may be necessary, is appropriated from the Transportation  
21 Safety Highway Hire-back Fund to the Department of

1 Transportation for agreements with the Illinois State Police  
2 to provide patrol officers in highway construction work zones.

3 AWARDS AND GRANTS

4 Section 105. The sum of \$4,300,900, or so much thereof as  
5 may be necessary, is appropriated from the Road Fund to the  
6 Department of Transportation for reimbursement to counties  
7 participating in the County Engineers Compensation Program for  
8 salaries in the period agreed upon by the parties without regard  
9 to state fiscal year. Such reimbursements may not exceed funds  
10 to be made available from the counties federal highway  
11 allocations retained by the Department.
