AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

5 Section 5. The amount of \$644,640,400, or so much thereof 6 as may be necessary, is appropriated from the Education 7 Assistance Fund to the Board of Trustees of the University of 8 Illinois to meet its operational expenses for the fiscal year 9 ending June 30, 2025.

Section 15. The sum of \$15,173,200, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for costs and expenses related to or in support of the Prairie HB5718 -2- OMB103 00391 KMH 45391 b Research Institute, in accordance with Public Act 95-0728.

2 Section 20. The sum of \$40,380,600, or so much thereof as 3 may be necessary, is appropriated from the General Revenue Fund 4 to the Board of Trustees of the University of Illinois for 5 operating costs and expenses related to or in support of the 6 University of Illinois Hospital.

Section 25. The sum of \$750,000, or so much thereof as may be necessary, is appropriated from the Education Assistance Fund to the Board of Trustees of the University of Illinois for costs associated with the Hispanic Center for Excellence at the Chicago campus.

Section 30. The sum of \$283,500, or so much thereof as may hereof as hereof hereof

The sum of \$1,079,000, or so much thereof as 17 may be necessary, is appropriated from the Education Assistance 18 Fund to the Board of Trustees of the University of Illinois for 19 costs associated with the Public Policy Institute at the 20 Chicago campus. -3- OMB103 00391 KMH 45391 b

Section 40. The sum of \$302,200, or so much thereof as may
be necessary, is appropriated from the Education Assistance
Fund to the Board of Trustees of the University of Illinois for
a grant to the College of Dentistry.

5 Section 45. The amount of \$500,000, or so much thereof as 6 may be necessary, is appropriated from the General Revenue Fund 7 to the Board of Trustees of the University of Illinois for 8 costs associated with the Illinois Heart Rescue.

9 Section 46. The sum of \$3,000,000, or so much thereof as 10 may be necessary, is appropriated to the University of Illinois 11 from the General Revenue Fund for a grant to the University of 12 Illinois at Springfield for the Illinois Innocence Project, and 13 any associated administrative expenses.

Section 50. The sum of \$5,671,200, or so much thereof as may be necessary, is appropriated from the Fire Prevention Fund to the Board of Trustees of the University of Illinois for the purpose of maintaining the Illinois Fire Service Institute, paying the Institute's expenses, and providing the facilities and structures incident thereto, including payment to the University for personal services and related costs incurred.

Section 55. The sum of \$250,000, or so much thereof as may

4 Section 60. The sum of \$250,000 or so much thereof as may 5 be necessary, is appropriated from the Pet Population Control 6 Fund to the University of Illinois for costs associated with 7 pet population control at the College of Veterinary Medicine.

8 Section 65. The sum of \$300,000, or so much thereof as may 9 be necessary, is appropriated from the Emergency Public Health 10 Fund to the University of Illinois for costs and expenses 11 related to or in support of Emergency Mosquito Abatement.

Section 70. The sum of \$400,000, or so much thereof as may be necessary, is appropriated from the Used Tire Management Fund to the University of Illinois for costs and expenses related to or in support of mosquito research and abatement.

16 Section 75. The sum of \$500,000, or so much thereof as may 17 be necessary, is appropriated from the Hazardous Waste Research 18 Fund to the University of Illinois for its ordinary and 19 contingent expenses.

20 Section 80. The sum of \$500,000, or so much thereof as may

be necessary, is appropriated from the General Professions Dedicated Fund to the Board of Trustees of the University of Illinois for costs associated with the development, support or administration of pharmacy practice education or training programs for the College of Medicine at Rockford.

6 Section 85. The sum of \$2,000,000, or so much thereof as 7 may be necessary, is appropriated from the Coal Technology 8 Development Assistance Fund to the University of Illinois for 9 the Prairie Research Institute for costs associated with carbon 10 dioxide capture technology at a coal-fired power plant, and 11 other projects in consultation with the United States 12 Department of Energy.

13 Section 90. The sum of \$2,000,000 or so much thereof as may 14 be necessary, is appropriated from the General Revenue Fund to 15 the Board of trustees of the University of Illinois for the 16 University's Climate Jobs Institute.

ARTICLE 2

18 Section 5. The sum of \$156,600, or so much thereof as may 19 be necessary, is appropriated from the State Coronavirus Urgent 20 Remediation Emergency Fund to the Board of Trustees of the 21 University of Illinois for costs associated with the water

rates report under Section 115 of the University of Illinois 1 2 Act, including but not limited to, for purposes permitted by Section 9901 of the American Rescue Plan Act of 2021 and related 3 federal guidance, including prior years' costs. No contract 4 5 shall be entered into or obligation incurred for water rates 6 report from appropriations made in this section until after the 7 purpose and amounts have been approved in writing by the 8 Governor.

9 Section 99. Effective date. This Act takes effect July 1,10 2024.
