1 AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1

Section 5. The sum of \$7,840,000, or so much thereof as may be necessary, is appropriated to the Illinois Student Assistance Commission from the General Revenue Fund to meet its operational expenses for the fiscal year ending June 30, 2025.

Section 10. The following named amount, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Illinois Student Assistance Commission for the following purpose:

To support outreach, research, and

Section 15. The sum of \$446,566,200, or so much thereof as may be necessary, is appropriated to the Illinois Student Assistance Commission from the General Revenue Fund for grant awards to students eligible for the Monetary Award Program, as provided by law, and for agency administrative and operational costs not to exceed 2 percent of the total appropriation for

- 1 the Monetary Award Program.
- 2 Section 20. The sum of \$265,000,000, or so much thereof
- 3 as may be necessary, is appropriated to the Illinois Student
- 4 Assistance Commission from the Education Assistance Fund for

- Section 155. The sum of \$2,500,000, or so much thereof as

- Section 160. The sum of \$2,500,000, or so much thereof as
- 6 may be necessary, is appropriated from the Illinois DREAM
- 7 Fund to the Illinois Student Assistance Commission to grant

- 9 the Illinois DREAM scholarship program.

The sum of \$200,000, or so much thereof as may be necessary and remains unexpended at the close of business 12 13 on June 30, 2024, from appropriations heretofore made for such 14 purpose in Article 123, Section 505 of Public Act 103-0006 as 15 amended, is reappropriated from the State Coronavirus Urgent 16 Remediation Emergency Fund to the Illinois Student Assistance 17 Commission for the Golden Apple Scholars of Illinois Program, 18 including but not limited to, for purposes permitted by Section 9901 of the American Rescue Plan Act of 2021 and related federal 19 20 quidance, including prior years' costs.
- 21 Section 10. The sum of \$1,300,000, or so much thereof as

- 1 may be necessary and remains unexpended at the close of business
- 2 on June 30, 2024, from appropriations heretofore made for such
- purpose in Article 123, Section 510 of Public Act 103-0006 as 3
- 4 amended, is reappropriated from the State Coronavirus Urgent
- 5 Remediation Emergency Fund to the Illinois Student Assistance
- 6 Commission for the Golden Apple Accelerators Program, including
- 7 but not limited to, for purposes permitted by Section 9901 of
- 8 the American Rescue Plan Act of 2021 and related federal
- guidance, including prior years' costs. 9
- 10 Section 99. Effective date. This Act takes effect July 1,
- 2024. 11
