WHEREAS, Prescribed fire provides multiple ecological, 2 3 economic, and cultural benefits to the State of Illinois; and

WHEREAS, Prescribed fire has been practiced for thousands of years and was a primary tool used by Indigenous peoples to attract game, to stimulate a rich ground layer of plants for 7 harvesting, and to keep woodlands and grasslands open and easy to traverse; and

9 WHEREAS, Prescribed fire is a traditional land management 10 practice and public safety tool that helps prevent and lessen the severity of wildfires; and 11

WHEREAS, Prescribed fire is a valuable tool used by forest, prairie, and wetland landowners and managers in reducing hazardous fuels, reducing the risk of destructive wildfires, preparing sites for both natural and artificial forest regeneration, improving access to and the appearance of land, and controlling detrimental insects and forest diseases; and

WHEREAS, Prescribed fire is an effective natural tool for controlling invasive species; and

- 1 WHEREAS, Prescribed fire is one of the most important land
- 2 management practices in maintaining and restoring healthy
- 3 landscapes, but only approximately six percent of conservation
- 4 lands in Illinois are currently being managed with prescribed
- 5 fire; and
- 6 WHEREAS, Prescribed fire is used to restore and maintain
- 7 fire-dependent ecosystems and to manage wildlife habitat for
- 8 many species; it is a vital tool to maintain economic,
- 9 biological, and aesthetic resources across Illinois; and
- 10 WHEREAS, The Illinois Prescribed Fire Council is an
- 11 organization of both public and private partners with a
- 12 mission to promote the safe and continued use of prescribed
- fire on the Illinois landscape; and
- WHEREAS, The Illinois General Assembly passed the Illinois
- 15 Prescribed Burning Act in 2007, defining prescribed fire as
- 16 "the planned application of fire to naturally occurring
- 17 vegetative fuels under specified environmental conditions and
- following appropriate precautionary measures, which causes the
- 19 fire to be confined to a predetermined area and accomplish the
- 20 planned land management objectives."; and
- 21 WHEREAS, Prescribed fire helps keep Illinois grasslands
- 22 and forests healthy, which, in return, provides ecological

- 1 services such as clean air and clean water and contributes to
- 2 the quality of life of the State's citizens and to local
- 3 economies; therefore, be it
- 4 RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE
- 5 HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that
- 6 we declare April of 2023 as "Prescribed Burning Awareness
- 7 Month" in the State of Illinois; and be it further
- 8 RESOLVED, That we support the appropriate and continued
- 9 use of prescribed fire in Illinois; and be it further
- 10 RESOLVED, That a suitable copy of this resolution be
- 11 presented to the Illinois Prescribed Fire Council as a symbol
- of our respect and esteem.
