## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The Community Behavioral Health Care 5 Professional Loan Repayment Program Act is amended by changing 6 Sections 25 and 30 as follows:

7 (110 ILCS 996/25)

Sec. 25. Award; maximum loan time; maximum amount. Subject 8 9 to appropriation, the Commission shall award a grant to each qualified applicant for a maximum of 4 years. The Commission 10 must encourage the recipient of a grant awarded under this Act 11 to use the grant award for payments towards the recipient's 12 educational loans. The amount of the grant shall not exceed 13 14 (i) <u>\$40,000</u> <del>\$35,000</del> per year for a psychiatrist, (ii) <u>\$20,000</u> \$15,000 per year for an advanced practice registered nurse or 15 16 a physician assistant, (iii) <u>\$20,000</u> <del>\$12,000</del> per year for a psychologist who holds a doctoral degree, (iv) \$15,000 \$6,500 17 per year for a licensed clinical social worker, or a licensed 18 19 clinical professional counselor, or a licensed marriage and family therapist, and (v) \$4,000 \$2,500 per year for a 20 21 substance use professional, a certified alcohol and drug 22 counselor, or a certified recovery support specialist, (vi) \$12,000 per year for a professional possessing a master's 23

degree in counseling, psychology, social work, or marriage and family therapy, and (vii) \$6,000 per year for a professional possessing a bachelor's degree in counseling, psychology, or social work.

5 No less than 30% of the funding for grants under this Section each fiscal year shall be reserved for awards to 6 minority applicants of African American or Black, Hispanic or 7 Latinx, Asian, or Native American origin. If the Commission 8 9 does not receive enough applications from qualified minorities 10 on or before January 1 of a given fiscal year to award 30% of 11 the funding to qualified minority applicants, then the 12 Commission may award a portion of these reserved funds to 13 other gualified applicants.

7 (4) He or she is a borrower with an outstanding
8 balance due on an educational loan.

9 (5) He or she has not defaulted on an educational 10 loan.

11 (b) The Commission may grant preference to a previous 12 recipient of a grant under the Program, provided that the 13 recipient continues to meet the eligibility requirements under 14 this Section.

(c) A recipient of a grant under the Program must complete a separate 12-month period working in a community mental health center in an underserved or rural federally designated Mental Health Professional Shortage Area in this State for each grant that he or she is awarded.
