SYNOPSIS AS INTRODUCED:

110 ILCS 330/6.8 new 210 ILCS 85/7.7 new

Amends the University of Illinois Hospital Act and Hospital Licensing Act. Provides that a hospital shall maintain a metal detector at each point of entry into the hospital. Provides that a hospital shall ensure that all members of the public, other than the employees of the hospital who display proper credentials, who enter the hospital at a point of entry are subjected to screening by a metal detector. Provides that individuals subject to screening shall include, but not be limited to, individuals in wheelchairs. Defines "point of entry". Effective July 1, 2023.

4 Section 5. The University of Illinois Hospital Act is 5 amended by adding Section 6.8 as follows:

7 Sec. 6.8. Metal detectors required. As used in this Section, "point of entry" means an entrance accessible to the 8 9 public. "Point of entry" does not include ambulance entrances. The University of Illinois Hospital shall maintain a metal 10 detector at each point of entry into the University of 11 Illinois Hospital. The University of Illinois Hospital shall 12 ensure that all members of the public, other than the 13 14 employees of the University of Illinois Hospital who display proper credentials, who enter the University of Illinois 15 16 Hospital at a point of entry are subjected to screening by a metal detector.
