1 AMENDMENT TO SENATE BILL 698

2 AMENDMENT NO. _____. Amend Senate Bill 698 on page 1, by
3 replacing lines 4 and 5 with the following:

4 "Section 1. Short title. This Act may be cited as the
5 Highway Work Zone Safety Act.

6 Section 5. Definitions. As used in this Act:

7 "Automatic traffic control system" means a photographic
8 device, radar device, laser device, or other electrical or
9 mechanical device or devices designed to record the speed of a
10 vehicle and obtain a clear photograph or other recorded image
11 of the vehicle, the vehicle operator, and the vehicle's
12 registration plate or digital registration plate while the
13 driver is violating Section 11-605.1 of the Illinois Vehicle
14 Code. The photograph or other recorded image must also display
15 the time, date, and location of the violation. A law
16 enforcement officer is not required to be present or to

1 witness the violation.

2 "Construction or maintenance speed zone" has the same
3 meaning given to that term under Section 11-605.1 of the
4 Illinois Vehicle Code.

5 "Motor vehicle rental company" has the meaning given to
6 that term under Section 6-305.3 of the Illinois Vehicle Code.

7 "Owner" means a person in whose name a motor vehicle is
8 registered under the laws of this State, another state, or a
9 foreign country or under the International Registration Plan.

10 "Program" means the Highway Work Zone Speed Control
11 Program created under this Act.

12 "Work zone speed limit" means a temporary speed limit
13 established for a work zone by (i) the Illinois Department of
14 Transportation and the Illinois State Toll Highway Authority,
15 or (ii) a unit of local government that has jurisdiction over
16 the work zone.

17 Section 10. Highway Work Zone Speed Control Program.

18 (a) The Illinois Department of Transportation, in
19 coordination with the Illinois State Police, shall establish
20 the Highway Work Zone Speed Control Program for the purposes
21 of enforcing the speed limits established for construction or
22 maintenance speed zones.

23 (b) The Illinois Department of Transportation shall
24 administer the Program in coordination with the Illinois State
25 Police and the Illinois State Toll Highway Authority.

1 (c) The Illinois State Police and the Illinois Department
2 of Transportation shall enter into an agreement to share
3 information regarding the Program.

4 (d) The Illinois Department of Transportation may enter
5 into an agreement with a third-party vendor to assist in the
6 administration of the Program.

7 Section 15. Procedures.

8 (a) The Illinois State Police, in conjunction with the
9 Illinois Department of Transportation and the Illinois State
10 Toll Highway Authority, shall set up and operate automated
11 traffic control systems in highway construction and
12 maintenance speed zones to detect violations of posted work
13 zone speed limits.

14 (b) Before setting up an automated traffic control system
15 for the purposes of the Program:

16 (1) the Illinois State Police and the Illinois
17 Department of Transportation may conduct a public
18 information campaign to inform drivers about the use of
19 automated traffic control systems to detect speeds in
20 excess of a work zone speed limit; and

21 (2) signs indicating that work zone speeds are
22 enforced by automated traffic control systems shall be
23 clearly posted in the areas where the systems are or will
24 be in use.

1 Section 20. Automated traffic control system operator
2 requirements; duties; restrictions. The Illinois Department of
3 Transportation or the Illinois State Police may employ
4 automated traffic control system operators to operate
5 automated traffic control systems in construction or
6 maintenance speed zones. The Illinois Department of
7 Transportation may adopt any rules necessary to establish
8 requirements, duties, or restrictions concerning automated
9 traffic control system operators.

10 Section 25. Photograph and recorded images; permitted and
11 nonpermitted uses.

12 (a) Except as otherwise provided in this Act, information
13 and photographs or recorded images collected under the Program
14 are not discoverable by court order as evidence in a
15 proceeding except to assess a penalty under Section 30 of this
16 Act.

17 (b) Information and a photograph or recorded image
18 collected under the Program must be destroyed not later than 2
19 years after the date the information and photograph or
20 recorded image is collected.

21 (c) Notwithstanding any other provision of law,
22 information and photographs or recorded images collected under
23 the Program are the exclusive property of the State and not the
24 property of the manufacturer or vendor of the automated
25 traffic control system.

1 (d) Except as otherwise provided under the Illinois
2 Vehicle Code or this Act, use of a photograph or recorded image
3 obtained through the use of an automated traffic control
4 system for the purpose of enforcing a traffic offense is
5 prohibited.

6 (e) A photograph or recorded image obtained through the
7 use of an automated traffic control system may not be used as
8 evidence in any action other than an action to collect a work
9 zone speed limit fine for which the photograph or recorded
10 image was obtained.

11 (f) A photograph or recorded image obtained through the
12 use of an automated traffic control system may be used
13 internally to administer the Program. However, unless
14 authorized by court order, a photograph or recorded image
15 obtained through the use of an automated traffic control
16 system may not be disclosed to anyone other than:

17 (1) the owner of the motor vehicle at the time the
18 recorded speed of the motor vehicle exceeded a work zone
19 speed limit;

20 (2) an individual alleged to have been operating the
21 motor vehicle at the time the work zone speed limit was
22 exceeded;

23 (3) an attorney representing an individual;

24 (4) a law enforcement officer;

25 (5) the Illinois State Police, the Illinois State Toll
26 Highway Authority, or the Illinois Department of

1 Transportation; or

2 (6) a court.

3 (g) The information and recorded images collected under
4 the Program are confidential and exempt from disclosure under
5 the Freedom of Information Act.

6 Section 30. Civil law violation.

7 (a) A person who owns a motor vehicle that is identified by
8 an automated traffic control system as operating in a
9 construction or maintenance speed zone at a speed in excess of
10 the posted speed limit commits a civil law violation.

11 (b) A person found to have committed a violation in
12 subsection (a) or subsection (c):

13 (1) is guilty of a civil law violation punishable by a
14 minimum fine of \$100 and a maximum fine of \$200. The
15 proceeds of the fine shall be payable to the clerk of the
16 circuit court. Within one month after the deposit of the
17 fine, the clerk shall distribute the proceeds of the fine
18 as follows:

19 (A) \$10 of the fine to the circuit clerk;

20 (B) \$10 of the fine to the State's Attorney;

21 (C) \$50 of the fine to the Transportation Safety
22 Highway Hire-back Fund in the State treasury;

23 (D) any remainder of the fine to the State Police
24 Vehicle Fund in the State treasury.

25 (2) With respect to funds designated for the Illinois

1 State Police, the moneys shall be remitted by the circuit
2 court clerk to the Illinois State Police within one month
3 after receipt for deposit into the State Police Vehicle
4 Fund.

5 (3) With respect to moneys designated for the Illinois
6 Department of Transportation, the moneys shall be remitted
7 by the circuit court clerk to the Illinois Department of
8 Transportation within one month after receipt for deposit
9 into the Transportation Safety Highway Hire-back Fund.

10 (c) A person found to have committed a third or subsequent
11 violation of subsection (a), and found to have failed to pay
12 all fines and costs within 30 days of the last judgment,
13 commits a separate civil law violation. The State may proceed
14 with collections in accordance with the law against a person
15 who is guilty under this Act but has failed to pay all fines
16 and costs.

17 Section 35. Vehicle rental or leasing company's
18 identification of a renter or lessee.

19 (a) A civil law violation issued under this Act to a motor
20 vehicle rental or leasing company shall be dismissed with
21 respect to the rental or leasing company if:

22 (1) the company responds to the civil law violation by
23 submitting, within 30 days of the mailing of the citation,
24 an affidavit of non-liability stating that, at the time of
25 the alleged speeding or other traffic violation, the

1 vehicle was in the custody and control of a renter or
2 lessee under the terms of a rental agreement or lease; and

3 (2) the company provides the driver's license number,
4 name, and address of the renter or lessee.

5 (b) A civil law violation dismissed with respect to a
6 motor vehicle rental or leasing company in accordance with
7 subsection (a) may then be issued and delivered by mail or
8 other means to the renter or lessee identified in the
9 affidavit of non-liability.

10 Section 40. Procurement. The Illinois Department of
11 Transportation may procure such as is necessary to implement
12 and administer this Act.

13 Section 45. Rulemaking. The Illinois Department of
14 Transportation shall adopt rules to implement and administer
15 this Act.

16 Section 900. The Freedom of Information Act is amended by
17 changing Section 7.5 as follows:

18 (5 ILCS 140/7.5)

22 the Architectural, Engineering, and Land Surveying
23 Qualifications Based Selection Act.

24 (g) Information the disclosure of which is restricted
25 and exempted under Section 50 of the Illinois Prepaid
26 Tuition Act.

1 (h) Information the disclosure of which is exempted
2 under the State Officials and Employees Ethics Act, and
3 records of any lawfully created State or local inspector
4 general's office that would be exempt if created or
5 obtained by an Executive Inspector General's office under
6 that Act.

7 (i) Information contained in a local emergency energy
8 plan submitted to a municipality in accordance with a
9 local emergency energy plan ordinance that is adopted
10 under Section 11-21.5-5 of the Illinois Municipal Code.

11 (j) Information and data concerning the distribution
12 of surcharge moneys collected and remitted by carriers
13 under the Emergency Telephone System Act.

14 (k) Law enforcement officer identification information
15 or driver identification information compiled by a law
16 enforcement agency or the Department of Transportation
17 under Section 11-212 of the Illinois Vehicle Code.

18 (l) Records and information provided to a residential
19 health care facility resident sexual assault and death
20 review team or the Executive Council under the Abuse
21 Prevention Review Team Act.

22 (m) Information provided to the predatory lending
23 database created pursuant to Article 3 of the Residential
24 Real Property Disclosure Act, except to the extent
25 authorized under that Article.

26 (n) Defense budgets and petitions for certification of

1 compensation and expenses for court appointed trial
2 counsel as provided under Sections 10 and 15 of the
3 Capital Crimes Litigation Act (repealed). This subsection
4 (n) shall apply until the conclusion of the trial of the
5 case, even if the prosecution chooses not to pursue the
6 death penalty prior to trial or sentencing.

7 (o) Information that is prohibited from being
8 disclosed under Section 4 of the Illinois Health and
9 Hazardous Substances Registry Act.

10 (p) Security portions of system safety program plans,
11 investigation reports, surveys, schedules, lists, data, or
12 information compiled, collected, or prepared by or for the
13 Department of Transportation under Sections 2705-300 and
14 2705-616 of the Department of Transportation Law of the
15 Civil Administrative Code of Illinois, the Regional
16 Transportation Authority under Section 2.11 of the
17 Regional Transportation Authority Act, or the St. Clair
18 County Transit District under the Bi-State Transit Safety
19 Act (repealed).

20 (q) Information prohibited from being disclosed by the
21 Personnel Record Review Act.

22 (r) Information prohibited from being disclosed by the
23 Illinois School Student Records Act.

24 (s) Information the disclosure of which is restricted
25 under Section 5-108 of the Public Utilities Act.

26 (t) (Blank).

1 (u) Records and information provided to an independent
2 team of experts under the Developmental Disability and
3 Mental Health Safety Act (also known as Brian's Law).

4 (v) Names and information of people who have applied
5 for or received Firearm Owner's Identification Cards under
6 the Firearm Owners Identification Card Act or applied for
7 or received a concealed carry license under the Firearm
8 Concealed Carry Act, unless otherwise authorized by the
9 Firearm Concealed Carry Act; and databases under the
10 Firearm Concealed Carry Act, records of the Concealed
11 Carry Licensing Review Board under the Firearm Concealed
12 Carry Act, and law enforcement agency objections under the
13 Firearm Concealed Carry Act.

14 (v-5) Records of the Firearm Owner's Identification
15 Card Review Board that are exempted from disclosure under
16 Section 10 of the Firearm Owners Identification Card Act.

17 (w) Personally identifiable information which is
18 exempted from disclosure under subsection (g) of Section
19 19.1 of the Toll Highway Act.

20 (x) Information which is exempted from disclosure
21 under Section 5-1014.3 of the Counties Code or Section
22 8-11-21 of the Illinois Municipal Code.

23 (y) Confidential information under the Adult
24 Protective Services Act and its predecessor enabling
25 statute, the Elder Abuse and Neglect Act, including
26 information about the identity and administrative finding

1 against any caregiver of a verified and substantiated
2 decision of abuse, neglect, or financial exploitation of
3 an eligible adult maintained in the Registry established
4 under Section 7.5 of the Adult Protective Services Act.

5 (z) Records and information provided to a fatality
6 review team or the Illinois Fatality Review Team Advisory
7 Council under Section 15 of the Adult Protective Services
8 Act.

9 (aa) Information which is exempted from disclosure
10 under Section 2.37 of the Wildlife Code.

11 (bb) Information which is or was prohibited from
12 disclosure by the Juvenile Court Act of 1987.

13 (cc) Recordings made under the Law Enforcement
14 Officer-Worn Body Camera Act, except to the extent
15 authorized under that Act.

16 (dd) Information that is prohibited from being
17 disclosed under Section 45 of the Condominium and Common
18 Interest Community Ombudsperson Act.

19 (ee) Information that is exempted from disclosure
20 under Section 30.1 of the Pharmacy Practice Act.

21 (ff) Information that is exempted from disclosure

6 "Apportionable Fee" means any periodic recurring fee
7 required for licensing or registering vehicles, such as, but
8 not limited to, registration fees, license or weight fees.

9 "Apportionable Vehicle" means any vehicle, except
10 recreational vehicles, vehicles displaying restricted plates,
11 city pickup and delivery vehicles, buses used in
12 transportation of chartered parties, and government owned
13 vehicles that are used or intended for use in 2 or more member
14 jurisdictions that allocate or proportionally register
15 vehicles, in a fleet which is used for the transportation of
16 persons for hire or the transportation of property and which
17 has a gross vehicle weight in excess of 26,000 pounds; or has
18 three or more axles regardless of weight; or is used in
19 combination when the weight of such combination exceeds 26,000
20 pounds gross vehicle weight. Vehicles, or combinations having
21 a gross vehicle weight of 26,000 pounds or less and two-axle
22 vehicles may be proportionally registered at the option of
23 such owner.

24 "Base Jurisdiction" means, for purposes of fleet
25 registration, the jurisdiction where the registrant has an
26 established place of business, where operational records of

1 the fleet are maintained and where mileage is accrued by the
2 fleet. In case a registrant operates more than one fleet, and
3 maintains records for each fleet in different places, the
4 "base jurisdiction" for a fleet shall be the jurisdiction
5 where an established place of business is maintained, where
6 records of the operation of that fleet are maintained and
7 where mileage is accrued by that fleet.

8 "Operational Records" means documents supporting miles
9 traveled in each jurisdiction and total miles traveled, such
10 as fuel reports, trip leases, and logs.

11 "Owner" means a person who holds legal title of a motor
12 vehicle, or in the event a motor vehicle is the subject of an
13 agreement for the conditional sale or lease thereof with the
14 right of purchase upon performance of the conditions stated in
15 the agreement and with an immediate right of possession vested
16 in the conditional vendee or lessee with right of purchase, or
17 in the event a mortgagor of such motor vehicle is entitled to
18 possession, or in the event a lessee of such motor vehicle is
19 entitled to possession or control, then such conditional
20 vendee or lessee with right of purchase or mortgagor or lessee
21 is considered to be the owner for the purpose of this Act.

9 respect to one or more rental fleets, in renting to others or

13 dealer, manufacturer, transporter, farm, reposessor, and
14 permanently mounted type plates. Vehicles displaying any of
15 these type plates from a foreign jurisdiction that is a member
16 of the International Registration Plan shall be granted
17 reciprocity but shall be subject to the same limitations as
18 similar plated Illinois registered vehicles.
