9	(a) Quick-take proceedings under	Article 20 may be used
10	for a period of one year after the	effective date of this
11	amendatory Act of the 103rd General Ass	sembly by the Village of
12	Deer Park for the acquisition of t	he following described
13	property for the purpose of a peri	manent Village utility
14	easement for the transmission of potable water:	

Part of 14-34-100-012, 20820 N. Rand Road

- 1 The Northerly 10 feet of the Property being a strip of land 10
- feet wide adjoining and parallel with the Southwesterly 2
- right-of-way line of Rand Road (U.S. Route 12), said 3
- 4 Southwesterly right-of-way line being 50 feet Southwesterly of
- 5 and parallel with the centerline of Rand Road as per Plat of
- 6 Highway recorded December 2, 1983 as Document No. 2254251.
- 7 The "Property" is legally described as:
- That part of the West Half of the North West Quarter of Section 8
- 9 34, Township 43 North, Range 10, East of the 3rd Principal
- 10 Meridian described as follows: Beginning on the West line of
- said Northwest Quarter at the Northwest corner of a tract of 11
- 12 land conveyed to Fritz Fisher by Warranty Deed dated August
- 13 10, 1868 and recorded April 2, 1869 in Book 46 of Deeds Page
- 14 552 (said point being 19.55 chains North of the Southwest
- 15 corner of said Quarter Section); thence North on said West
- line 8.59 chains, more or less, to the center of Chicago Road 16
- (so called); thence South 62 Degrees East in the center of said 17
- Road, 11.30 chains; thence South 3.40 chains to the North line 18
- 19 of said Fisher's land; thence West on said North line to the
- 20 place of beginning (excepting therefrom that party lying
- 21 Westerly of the following described line: Beginning at the
- 22 Northeasterly corner of Creamery Lot as described in deed
- recorded as Document 27470; thence Southwesterly along the 23
- 24 Southeasterly line of said Lot to the Southeasterly corner of
- 25 said Lot; thence South to a point in the North line of said
- Fritz Fisher land, said point being 308.73 feet East of the 26

- Northwest corner of said Fisher's land), and also excepting 1
- therefrom that part lying Northeasterly of and adjoining the 2
- 3 Southwesterly right of way of Rand Road (U.S. 12), all in Lake
- 4 County, Illinois.
- 5 (b) This Section is repealed 3 years after the effective
- date of this amendatory Act of the 103rd General Assembly. 6
- 7 Section 99. Effective date. This Act takes effect upon
- 8 becoming law.".
