2	AMENDMENT NO Amend Senate Bill 1217 by replacing
3	everything after the enacting clause with the following:
4 5	"Section 5. The Illinois Vehicle Code is amended by changing Section 6-109 as follows:
6	(625 ILCS 5/6-109)
7	Sec. 6-109. Examination of applicants.
8	(a) The Secretary of State shall examine every applicant
9	for a driver's license or permit who has not been previously
10	licensed as a driver under the laws of this State or any other
11	state or country, or any applicant for renewal of such
12	driver's license or permit when such license or permit has
13	been expired for more than one year. The Secretary of State
14	shall, subject to the provisions of paragraph (c), examine
15	every licensed driver at least every 8 years, and may examine
16	or re-examine any other applicant or licensed driver, provided

1 that during the years 1984 through 1991 those drivers issued a 2 license for 3 years may be re-examined not less than every 7 3 years or more than every 10 years.

The Secretary of State shall require the testing of the eyesight of any driver's license or permit applicant who has not been previously licensed as a driver under the laws of this State and shall promulgate rules and regulations to provide for the orderly administration of all the provisions of this Section.

10 The Secretary of State shall include at least one test 11 question that concerns the provisions of the Pedestrians with 12 Disabilities Safety Act in the question pool used for the 13 written portion of the driver's license examination within one 14 year after July 22, 2010 (the effective date of Public Act 15 96-1167).

The Secretary of State shall include, in the question pool used for the written portion of the driver's license examination, test questions concerning safe driving in the presence of bicycles, of which one may be concerning the Dutch Reach method as described in Section 2-112.

The Secretary of State shall include, in the question pool used for the written portion of the driver's license examination, at least one test question concerning driver responsibilities when approaching a stationary emergency vehicle as described in Section 11-907.

paragraph (c), such examination shall include a test of the 1 applicant's eyesight, his or her ability to read 2 and understand official traffic control devices, his or 3 her 4 knowledge of safe driving practices and the traffic laws of 5 this State, and may include an actual demonstration of the applicant's ability to exercise ordinary and reasonable 6 control of the operation of a motor vehicle, and such further 7 physical and mental examination as the Secretary of State 8 9 finds necessary to determine the applicant's fitness to 10 operate a motor vehicle safely on the highways, except the examination of an applicant 75 years of age or older or, if the 11 Secretary adopts rules under Section 37 of the Secretary of 12 State Act to raise the age requirement for actual 13 demonstrations, the examination of an applicant who has 14 15 attained that increased age or is older shall include an 16 actual demonstration of the applicant's ability to exercise 17 ordinary and reasonable control of the operation of a motor vehicle. All portions of written and verbal examinations under 18 this Section, excepting where the English language appears on 19 20 facsimiles of road signs, may be given in the Spanish language and, at the discretion of the Secretary of State, in any other 21 22 language as well as in English upon request of the examinee. Deaf persons who are otherwise qualified are not prohibited 23 24 from being issued a license, other than a commercial driver's 25 license, under this Code.

1 renewing their driver's license possess a driving record devoid of any convictions of traffic violations or evidence of 2 committing an offense for which mandatory revocation would be 3 required upon conviction pursuant to Section 6-205 at the time 4 5 of renewal shall be in a manner prescribed by the Secretary in 6 order to determine an applicant's ability to safely operate a 7 motor vehicle, except that every applicant for the renewal of a driver's license who is 75 years of age or older or, if the 8 9 Secretary adopts rules under Section 37 of the Secretary of 10 State Act to raise the age requirement for actual 11 demonstrations, every applicant for the renewal of a driver's 12 license who has attained that increased age or is older must 13 prove, by an actual demonstration, the applicant's ability to exercise reasonable care in the safe operation of a motor 14 15 vehicle.

(d) In the event the applicant is not ineligible under the provisions of Section 6-103 to receive a driver's license, the Secretary of State shall make provision for giving an examination, either in the county where the applicant resides or at a place adjacent thereto reasonably convenient to the applicant, within not more than 30 days from the date said application is received.

(e) The Secretary of State may adopt rules regarding the
use of foreign language interpreters during the application
and examination process.
