## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 1. This Act may be referred to as the Donald (DJ)
Stallworth, III Act.

9 Sec. 11-1421. Conditions for operating ambulances and 10 rescue vehicles.

11 (a) No person shall operate an ambulance or rescue vehicle 12 in a manner not conforming to the motor vehicle laws and 13 regulations of this State or of any political subdivision of 14 this State as such laws and regulations apply to motor 15 vehicles in general, unless in compliance with the following 16 conditions:

170.5. The operator of the ambulance or rescue vehicle18shall have documented training in the operation of an19ambulance or rescue vehicle prior to operating that20vehicle. This training shall include the proper use of21warning lights and sirens, situations where warning lights22and sirens are warranted, and the provisions of this

The person operating the ambulance shall be either
 responding to a bona fide emergency call or specifically
 directed by a licensed physician to disregard traffic laws
 in operating the ambulance during and for the purpose of
 the specific trip or journey that is involved;

7 2. The ambulance or rescue vehicle shall be equipped 8 with a siren producing an audible signal of an intensity 9 of 100 decibels at a distance of 50 feet from the siren, 10 and with a lamp or lamps emitting an oscillating, rotating 11 or flashing red beam directed in part toward the front of 12 vehicle, and these lamps shall have sufficient the intensity to be visible at 500 feet in normal sunlight, 13 14 and in addition to other lighting requirements, excluding 15 those vehicles operated in counties with a population in 16 excess of 2,000,000, may also operate with a lamp or lamps 17 emitting an oscillating, rotating, or flashing green 18 light;

19 3. The aforesaid siren and lamp or lamps shall be in 20 operation at all times when it is reasonably necessary to 21 warn pedestrians and other drivers of the approach thereof 22 during such trip or journey, except that in a municipality 23 with a population over 1,000,000, the siren and lamp or lamps shall be in operation only when it is reasonably 24 25 necessary to warn pedestrians and other drivers of the 26 approach thereof while responding to an emergency call or

1 transporting a patient who presents a combination of 2 circumstances resulting in a need for immediate medical 3 intervention;

4. Whenever the ambulance or rescue vehicle is 4 5 operated at a speed in excess of 40 miles per hour, the 6 ambulance or rescue vehicle shall be operated in complete 7 conformance with every other motor vehicle law and 8 regulation of this State and of the political subdivision 9 in which the ambulance or rescue vehicle is operated, 10 relating to the operation of motor vehicles, as such 11 provision applies to motor vehicles in general, except 12 and regulations pertaining to compliance with laws 13 official traffic-control devices or to vehicular operation 14 upon the right half of the roadway; and

15 5. The ambulance shall display registration plates16 identifying the vehicle as an ambulance.

17 <u>(a-5) The driver of an ambulance or rescue vehicle may</u> 18 proceed past a red traffic control signal or stop sign if the 19 <u>ambulance or rescue vehicle is making use of both the audible</u> 20 <u>and visual signals meeting the requirement of this Section,</u> 21 <u>but only after slowing down as necessary for safe operation.</u>

(b) The foregoing provisions do not relieve the driver of an ambulance or rescue vehicle from the duty of driving with due regard for the safety of all persons, nor do such provisions protect the driver from the consequences resulting from the reckless disregard for the safety of others.
