SYNOPSIS AS INTRODUCED:

720 ILCS 5/9-3.3

from Ch. 38, par. 9-3.3

Amends the Criminal Code of 2012. Provides that a person commits drug-induced homicide when he or she violates delivery of a controlled substance or methamphetamine or a similar law of another jurisdiction, by unlawfully delivering a controlled substance to another, and the injection, inhalation, absorption, or ingestion of any amount of that controlled substance is a contributing cause of the person's death.

AN ACT concerning criminal law.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The Criminal Code of 2012 is amended by 5 changing Section 9-3.3 as follows:

6 (720 ILCS 5/9-3.3) (from Ch. 38, par. 9-3.3)

7 Sec. 9-3.3. Drug-induced homicide.

(a) A person commits drug-induced homicide when he or she 8 9 violates Section 401 of the Illinois Controlled Substances Act or Section 55 of the Methamphetamine Control and Community 10 Protection Act by unlawfully delivering a controlled substance 11 to another, and any person's death is caused by the injection, 12 13 inhalation, absorption, or ingestion of any amount of that 14 controlled substance or the injection, inhalation, absorption, or ingestion of any amount of that controlled substance is a 15 16 contributing cause of the person's death.

(a-5) A person commits drug-induced homicide when he or 17 she violates the law of another jurisdiction, which if the 18 19 violation had been committed in this State could be charged under Section 401 of the Illinois Controlled Substances Act or 20 21 Section 55 of the Methamphetamine Control and Community 22 Protection Act, by unlawfully delivering controlled а substance to another, and any person's death is caused in this 23

1 State by the injection, inhalation, absorption, or ingestion 2 of any amount of that controlled substance <u>or the injection</u>, 3 <u>inhalation, absorption, or ingestion of any amount of that</u> 4 <u>controlled substance is a contributing cause of the person's</u> 5 death.

6 (b) Sentence. Drug-induced homicide is a Class X felony,
7 except:

8 (1) A person who commits drug-induced homicide by 9 violating subsection (a) or subsection (c) of Section 401 10 of the Illinois Controlled Substances Act or Section 55 of 11 the Methamphetamine Control and Community Protection Act 12 commits a Class X felony for which the defendant shall in 13 addition to a sentence authorized by law, be sentenced to a term of imprisonment of not less than 15 years and not 14 15 more than 30 years or an extended term of not less than 30 16 years and not more than 60 years.

17 (2) A person who commits drug-induced homicide by violating the law of another jurisdiction, which if the 18 violation had been committed in this State could be 19 20 charged under subsection (a) or subsection (c) of Section 401 of the Illinois Controlled Substances Act or Section 21 22 55 of the Methamphetamine Control and Community Protection 23 Act, commits a Class X felony for which the defendant 24 shall, in addition to a sentence authorized by law, be 25 sentenced to a term of imprisonment of not less than 15 26 years and not more than 30 years or an extended term of not
