- (b) Members of the Advisory Board shall serve for terms of 3 years or until the member's successor is appointed by the Director, but the Director shall stagger the terms of initial appointees to the Advisory Board as follows: the terms of one-third shall expire after one year; the terms of one-third shall expire after 2 years; and the terms of one-third shall expire after 3 years. All initial members shall be appointed by January 1, 2025. Any member appointed to fill a vacancy occurring before the expiration of the term for which his or her predecessor was appointed shall be appointed for the remainder of that term. The Advisory Board shall meet quarterly and at the call of the Director. The affirmative vote of 9 voting members of the Advisory Board shall be necessary for any action of the Advisory Board. Members of the Advisory Board shall receive no compensation for their
