

103RD GENERAL ASSEMBLY State of Illinois 2023 and 2024 SB1939

SYNOPSIS AS INTRODUCED:

55 ILCS 5/5-12022 new 60 ILCS 1/110-17 new 65 ILCS 5/11-13-28 new

Amends the Counties Code, Township Code, and Illinois Municipal Code. Provides that a disabled veteran or the disabled veteran's caregiver shall not be charged any building permit fee for improvements to the residence of the disabled veteran if the improvements are required to accommodate a disability of the veteran. Provides that the paperwork required to obtain a building permit must still be submitted. Limits home rule powers. Effective January 1, 2024.

STATE MANDATES ACT MAY REQUIRE REIMBURSEMENT 1 AN ACT concerning local government.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Counties Code is amended by adding Section 5-12022 as follows:

- 7 <u>Sec. 5-12022. Disabled veteran building permit fee.</u>
- 8 (a) A disabled veteran or the disabled veteran's caregiver

- 11 <u>are required to accommodate a disability of the veteran.</u>
- 12 Nothing in this subsection changes the obligation of any

- 21 Section 10. The Township Code is amended by adding Section
- 110-17 as follows:

2 Sec. 110-17. Disabled veteran building permit fee. A 3 disabled veteran or the disabled veteran's caregiver shall not 4 be charged any building permit fee for improvements to the 5 residence of the disabled veteran if the improvements are required to accommodate a disability of the veteran. Nothing 6 in this Section changes the obligation of any person to submit 7 to the township applications, forms, or other paperwork to 8 9 obtain a building permit.

- Section 15. The Illinois Municipal Code is amended by adding Section 11-13-28 as follows:

- 13 Sec. 11-13-28. Disabled veteran building permit fee.
- (a) A disabled veteran or the disabled veteran's caregiver

 shall not be charged any building permit fee for improvements
