Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The School Code is amended by changing Section
2-3.163 as follows:

(a) The General Assembly makes all of the following 10 11 findings: 12 (1) Pursuant to Section 10-26 of the Department of Human Services Act, the The Department of Human Services 13 14 maintains a statewide database known as the PUNS database Prioritization of Urgency of Need for Services that 15 16 records information about individuals with intellectual 17 disabilities or developmental disabilities who are potentially in need of services. 18

19 (2) The Department of Human Services uses the data on
 20 <u>PUNS</u> Prioritization of Urgency of Need for Services to
 21 select individuals for services as funding becomes
 22 available, to develop proposals and materials for
 23 budgeting, and to plan for future needs.

1(3) The PUNS databasePrioritization of Urgency of2Need for Services is available for children and adults3with intellectual disabilities or a developmental4disabilities disability who have an unmet service needs5need anticipated in the next 5 years. The PUNS database is6also available for children with intellectual disabilities7or developmental disabilities with unmet service needs.

8 (4) Registration to be included on the PUNS database 9 Prioritization of Urgency of Need for Services is the 10 first step toward <u>receiving</u> getting developmental 11 disabilities services in this State. A child or an adult 12 who is If individuals are not on the PUNS database will not be Prioritization of Urgency of Need for Services waiting 13 list, they are not in queue for State developmental 14 15 disabilities services.

16 (5) Lack of awareness and information about the PUNS 17 database results in underutilization or delays in registration for the PUNS database by students with 18 intellectual disabilities or developmental disabilities 19 20 and their parents or guardians Prioritization of Urgency 21 of Need for Services may be underutilized by children and 22 their parents or quardians due to lack of awareness or 23 lack of information.

24 (a-5) The purpose of this Section is to ensure that each
 25 student with an intellectual disability or a developmental

and the student's parents or quardian are informed about the 1 2 PUNS database, where to register for the PUNS database, and 3 whom they can contact for information about the PUNS database and the PUNS database registration process. This Section is 4 5 not intended to change the PUNS database registration process established by the Department of Human Services or to impose 6 any responsibility on the State Board of Education or a school 7 8 district to register students for the PUNS database.

9 <u>(a-10) As used in this Section, "PUNS" means the</u> 10 <u>Prioritization of Urgency of Need for Services database or</u> 11 <u>PUNS database developed and maintained by the Department of</u> 12 <u>Human Services pursuant to Section 10-26 of the Department of</u> 13 <u>Human Services Act.</u>

(b) The State Board of Education may work <u>in consultation</u> with the Department of Human Services and with school districts to <u>ensure that inform</u> all students with <u>intellectual</u> <u>disabilities or</u> developmental disabilities and their parents or guardians <u>are informed</u> about the <u>PUNS</u> Prioritization of Urgency of Need for Services database, as described in <u>subsections (c), (c-5), and (d) of this Section</u>.

Prioritization of Urgency of Need for Services database and 1 2 steps required to register students for the PUNS database, including the documentation and information parents or 3 guardians will need for the registration process to be taken 4 to ensure children and adolescents are enrolled. The training 5 shall include instruction on identifying and contacting for at 6 least one designated employee in every public school in 7 8 the appropriate developmental disabilities contacting 9 Independent Service Coordination agency ("ISC") to register 10 students for the PUNS database enroll children and adolescents 11 in the database. The training of the designated employee or 12 employees shall also include information about organizations 13 and programs available in this State that offer assistance to 14 families in understanding the PUNS database and navigating the PUNS database registration process. Each school district shall 15 16 post on its public website and include in its student handbook 17 the names of the designated trained employee or employees in each school within the school district. At least 18 one designated employee in every public school shall ensure the 19 20 opportunity to enroll in the Prioritization of Urgency of Need 21 for Services database is discussed during annual 22 individualized education program (IEP) meetings for $\frac{1}{a}$ 23 children and adolescents believed to have a -developmental disability. 24

25 (c-5) During the student's annual IEP review meeting, if
 26 the student has an intellectual disability or a developmental

disability, the student's IEP team shall determine the 1 2 student's PUNS database registration status based upon 3 information provided by the student's parents or guardian or by the student. If it is determined that the student is not 4 5 registered for the PUNS database or if it is unclear whether the student is registered for the PUNS database, the parents 6 7 or guardian and the student shall be referred to a designated 8 employee of the public school who has completed the training 9 described in subsection (c). The designated trained employee shall provide the student's parents or guardian and the 10 student with the name, location, and contact information of 11 12 the appropriate ISC to contact in order to register the 13 student for the PUNS database. The designated trained employee 14 shall also identify for the parents or guardian and the student the information and documentation they will need to 15 16 complete the PUNS database registration process with the ISC, 17 and shall also provide information to the parents or quardian and the student about organizations and programs available in 18 19 this State that offer information to families about the PUNS database and the PUNS database registration process. 20

(d) The State Board of Education, in consultation with the Department of Human Services, through school districts, shall provide to <u>the</u> parents and guardians of <u>each student with an</u> <u>IEP students</u> a copy of <u>the latest version of</u> the Department of Human Services's guide titled "Understanding PUNS: A Guide to Prioritization for Urgency of Need for Services" each year at SB2039 Enrolled - 6 - LRB103 27611 RJT 53987 b

1 the annual review meeting for the student's individualized 2 education program, including the consideration required in 3 subsection (c) of this Section.

4 (e) <u>(Blank).</u> The Department of Human Services shall 5 consider the length of time spent on the Prioritization of 6 Urgency of Need for Services waiting list, in addition to 7 other factors considered, when selecting individuals on the 8 list for services.
