11	payment. When a vehicle is authorized to be towed away as
12	provided in Section 4-202 or 4-203:
13	(a) The authorization, <u>the name of the registered</u>
14	owner of the vehicle, the contact information of the
15	registered owner of the vehicle, any hold order, and any
16	release shall be in writing, or confirmed in writing, with
17	a copy given to the towing service.
18	(b) The police headquarters or office of the law
19	officer authorizing the towing shall keep and maintain a
20	record of the vehicle towed, listing the color, year of
21	manufacture, manufacturer's trade name, manufacturer's
22	series name, body style, Vehicle Identification Number,
23	license plate or digital license plate year and number and
24	registration sticker or digital registration sticker year

and number displayed on the vehicle. The record shall also include the date and hour of tow, location towed from, location towed to, reason for towing and the name of the officer authorizing the tow.

5 (c) The owner, operator, or other legally entitled person shall be responsible to the towing service for 6 payment of applicable removal, towing, storage, 7 and 8 processing charges and collection costs associated with a 9 vehicle towed or held under order or authorization of a 10 law enforcement agency. If a vehicle towed or held under order or authorization of a law enforcement agency is 11 12 seized by the ordering or authorizing agency or any other 13 law enforcement or governmental agency and sold, anv 14 unpaid removal, towing, storage, and processing charges 15 and collection costs shall be paid to the towing service from the proceeds of the sale. If applicable law provides 16 17 that the proceeds are to be paid into the treasury of the appropriate civil jurisdiction, then any unpaid removal, 18 19 towing, storage, and processing charges and collection 20 costs shall be paid to the towing service from the 21 treasury of the civil jurisdiction. That payment shall 22 not, however, exceed the amount of proceeds from the sale, 23 with the balance to be paid by the owner, operator, or 24 other legally entitled person.

(d) Upon delivery of a written release order to the
towing service, a vehicle subject to a hold order shall be

1 released to the owner, operator, or other legally entitled 2 person upon proof of ownership or other entitlement and 3 upon payment of applicable removal, towing, storage, and 4 processing charges and collection costs.
