SYNOPSIS AS INTRODUCED:

310 ILCS 75/2	from Ch.	67	1/2,	par.	1352
310 ILCS 75/4	from Ch.	67	1/2,	par.	1354

Amends the Subsidized Housing Joint Occupancy Act. Provides that an elderly parent with an adult child with disabilities of the opposite sex shall not be required to occupy subsidized housing with only one bedroom. Provides that exceptions to the largest permissible unit size for subsidized housing shall be made when the elderly parent and adult child with disabilities of the opposite sex otherwise meet all other eligibility requirements.

1 AN ACT concerning housing.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The Subsidized Housing Joint Occupancy Act is 5 amended by changing Sections 2 and 4 as follows:

6 (310 ILCS 75/2) (from Ch. 67 1/2, par. 1352)

Sec. 2. Legislative findings. The General Assembly makesthe following findings:

9 (1) Elderly persons and persons with disabilities 10 frequently desire to share a residence (i) to maximize the 11 effectiveness of the portion of their often limited incomes 12 that is spent for housing; (ii) for protection; and (iii) for 13 assistance in performing necessary daily tasks of life such as 14 cooking and cleaning.

15 <u>(1-5) Elderly parents of adult children with disabilities</u> 16 <u>frequently desire to share a residence with their adult child</u> 17 <u>with disabilities (i) to maximize the effectiveness of the</u> 18 <u>portion of their often-limited incomes that is spent for</u> 19 <u>housing; (ii) for protection; and (iii) for assistance in</u> 20 <u>performing necessary daily tasks of life such as cooking and</u> 21 <u>cleaning.</u>

(2) Many elderly persons and persons with disabilities
 desire to live in federally subsidized housing units because

1 of their limited incomes.

(3) Rules of the federal Department of Housing and Urban
Development permit 2 or more unrelated elderly persons or
persons with disabilities to occupy the same unit in federally
subsidized housing, although local housing authorities
frequently do not permit those persons to occupy the same
unit.

8 <u>(3-5) Rules of the U.S. Department of Housing and Urban</u> 9 <u>Development do not force persons of different generations or</u> 10 <u>opposite sex to share the same bedroom in federally subsidized</u> 11 <u>housing, although local housing authorities frequently require</u> 12 <u>that living situation based upon the local housing authority's</u> 13 <u>occupancy standards.</u>

14 (4) The State of Illinois should do all it can to assist 15 its elderly persons and persons with disabilities in 16 maximizing the effectiveness of their incomes and to insure 17 that those citizens are not unnecessarily burdened in 18 accomplishing the daily tasks of life.

Sec. 4. Joint occupancy of subsidized housing.

22 <u>(a)</u> Two elderly persons or two persons with disabilities 23 who are not related to each other by blood or marriage shall 24 not be prohibited from jointly occupying subsidized housing or 25 a unit of subsidized housing solely because they are not SB3351 - 3 - LRB103 38388 KTG 68523 b

1 related, provided they have filed a form for such joint 2 occupation with the clerk of the county in which the housing 3 they seek to occupy is located and otherwise meet all other 4 eligibility requirements. A member of the joint occupancy may 5 withdraw from the joint occupancy at any time.

6 (b) An elderly parent with an adult child with 7 disabilities of the opposite sex shall not be required to 8 occupy subsidized housing with only one bedroom. Exceptions to 9 the largest permissible unit size for subsidized housing shall 10 be made when the elderly parent and adult child with 11 disabilities of the opposite sex otherwise meet all other 12 eligibility requirements.
