- for portable batteries and by no later than December 31, 2028
- for medium-format batteries" with "December 31, 2028"; and

- 16 "Section 95. Agency-sponsored household battery recycling
- 17 program. If the Agency receives funding to support an
- 18 Agency-sponsored household battery recycling program that
- 19 operates concurrently with the Battery Stewardship Program
- 20 that is the subject of this Act, the costs of collecting and
- 21 managing batteries through the Agency-sponsored household

- battery recycling program shall not be the responsibility of 1
- 2 the battery stewardship organization.".
