A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named sums, or so much thereof  
6 as may be necessary, respectively, for the objects and purposes  
7 hereinafter named, are appropriated to meet the ordinary and  
8 contingent expenses of the Department of Labor:

11 Payable from General Revenue Fund:

1 Wage Payment and Collection Act.

2 Section 30. The amount of \$2,000,000, or so much thereof  
3 as may be necessary, is appropriated from the Department of  
4 Labor Federal Trust Fund to the Department of Labor for all  
5 costs associated with promoting and enforcing the occupational  
6 safety and health administration state program for public  
7 sector worksites.

8 Section 35. The amount of \$4,000,000, or so much thereof  
9 as necessary, is appropriated from the Federal Industrial  
10 Services Fund to the Department of Labor for administrative and  
11 other expenses and for the Occupational Safety and Health  
12 Administration Program, including refunds and prior years'  
13 costs.

14 Section 40. The amount of \$400,000, or so much thereof as  
15 may be necessary, is appropriated from the Department of Labor  
16 Federal Indirect Cost Fund to the Department of Labor for all  
17 costs associated with OSHA Indirect Costs.

18 Section 45. The sum of \$1,000,000, or so much thereof as  
19 may be necessary, is appropriated from the Equal Pay Fund to  
20 the Department of Labor for all costs associated with the  
21 administration of the Equal Pay Act of 2003.

1           Section 50. The sum of \$401,500, or so much thereof as may  
2 be necessary, is appropriated from the General Revenue Fund to  
3 the Department of Labor for all costs associated with the  
4 administration of the Equal Pay Act of 2003.

5           Section 55. The sum of \$895,700, or so much thereof as may  
6 be necessary, is appropriated from the General Revenue Fund to  
7 the Department of Labor for costs associated with the  
8 administration of the Nurse Agency Licensing Act.

9

10          Section 60. The sum of \$812,300, or so much thereof as may  
11 be necessary, is appropriated from the General Revenue Fund to  
12 the Department of Labor for costs associated with the  
13 administration of the Paid Leave for All Workers Act.

14          Section 99. Effective date. This Act takes effect July 1,  
15 2024.
